Hyperadrenocorticism: Clinical Update

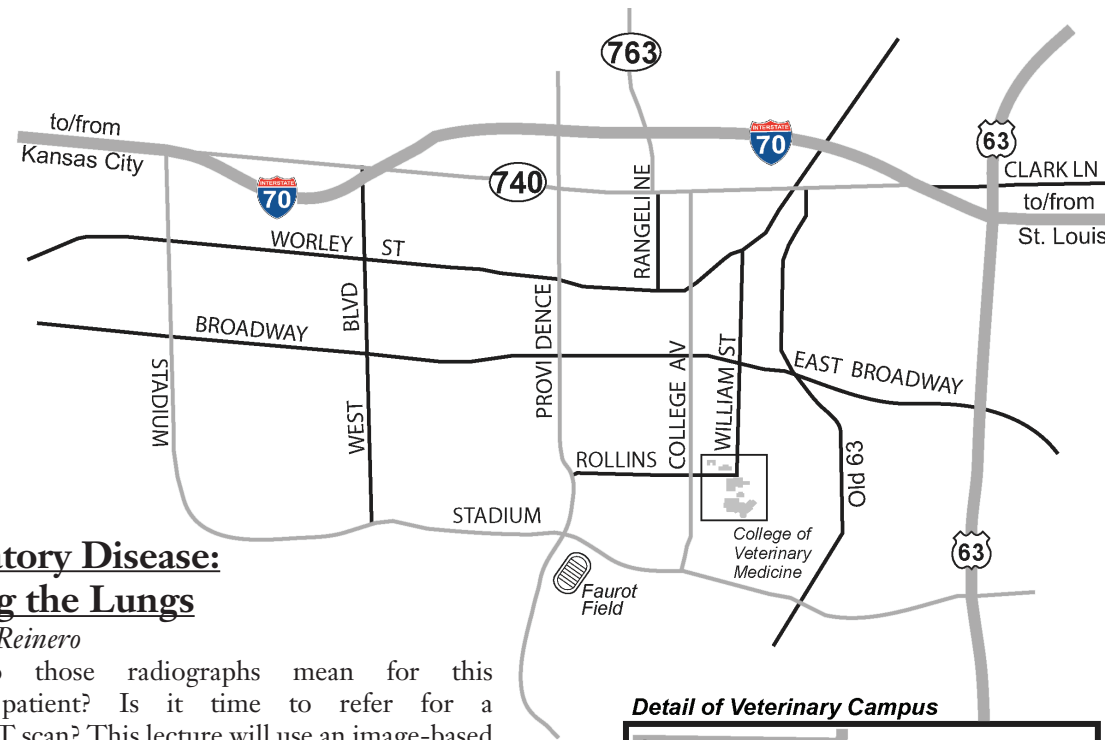

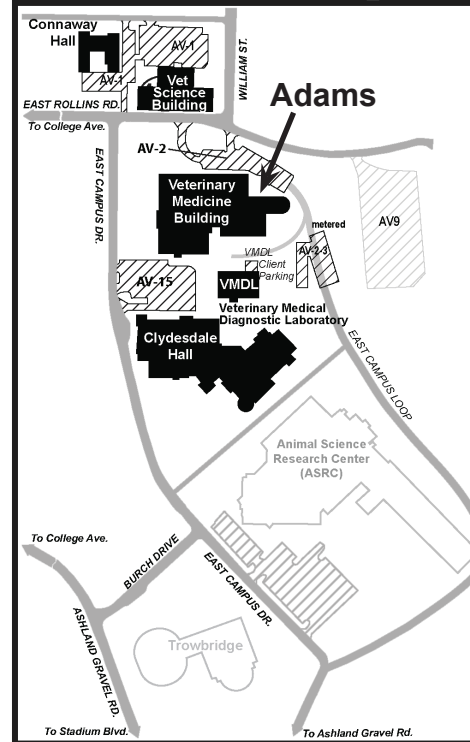
Fungal Disease Diagnosis and Treatment: What's New?
