Journalism Week at Missouri

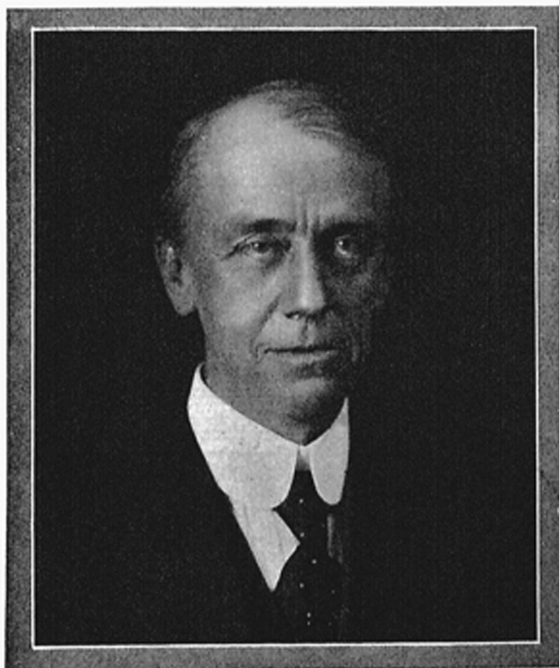

Journalism Week at the University of Missouri has become an institution. It had its beginning in Switzler Hall in 1910. This year Monday, Tuesday, Wednesday, Thursday, Friday and Saturday, May 10, 11, 12, 13, 14 and 15, will be the seventeenth annual Journalism Week. Missouri is a pioneer in thus assembling newspaper men and newspaper women in annual conference with Journalism students as in the establishment of a school of Journalism. Newspaper institutes, newspaper conferences, journalism days and weeks are now held in connection with many universities and colleges.

Journalism Week brings to the University of Missouri newspaper workers not only from Missouri but from other states and from foreign countries. In the roll of attendants are found the names of many of the most distinguished journalists and publicists. The great capitals of the World, Washington, London, Paris, Tokyo, Rio de Janeiro, have been represented among the speakers, and addresses upon all phases of the profession of journalism have been on the programs.

Journalism Week has for its object the discussion of the purposes and problems of the profession of journalism in its various aspects, seeking by conference and consideration, by lecture and discussion, to bring helpfully before the journalism students and the journalistic visitors journalism as a profession of public service.

The experiences related, the discussions had, the acquaintanceships formed have been of inestimable value to those who have had the privilege of attending the annual Journalism Week. The Week is recognized by the Missouri Press Association as a most important feature of its work—so much so that one of the Association's semi-annual meetings is yearly held during Journalism Week at the University of Missouri. The Missouri Writers' Guild, organized at an early Journalism Week, continues to hold, by constitutional provision, its annual session at the University during the Week. The Association of Past Presidents of the Missouri Press



Dean Walter Williams of the School of Journalism was signally honored by being elected permanent chairman of the Pan-American Congress, at their meeting in Washington on April 7. Twenty-one republics were represented. He has been granted a leave of absence during September and October, in order that he may attend the meeting of the Press Congress of the World of which he is the president. The Congress will meet in Geneva, Switzerland.

Association, the Missouri Associated Dailies, and other journalistic organizations meet in Columbia at the same time.

The proceedings of the Week, published in pamphlet form as one of the series of bulletins of the School of Journalism, have attracted wide interest. The demand for these bulletins has been so large that, without exception, they are out of print soon after their publication.

Journalism Week closes the formal program with a banquet distinctive and unique. This year the closing banquet, in Rothwell Gymnasium Friday evening, May 14, will be a "King Features Banquet," illustrating the humor and special features of the present-day newspaper.

All newspaper makers are welcomed to

Journalism Week and it is believed each will find in the proceedings something of genuine value and inspiration.

Special Program Is Planned For Journalism Alumni Day

JOURNALISM Alumni Day and the presentation of Dean Walter Williams' portrait to the School of Journalism will be two of the outstanding features of this year's Journalism Week.

Thursday, May 13, has been allotted to the alumni. Dean Walter Williams and Rex Magee of Jackson, Miss., president of the School of Journalism Alumni Association, will be presiding officers. There will be talks on different phases of journalism by alumni and former students. The 1916 graduating class will have its tenth anniversary reunion; the new Missourian board will hold election; and there will be the annual business session of the Journalism Alumni Association. The portrait of Dean Williams, painted by Charles F. Galt of St. Louis, will be presented in a brief, impressive, and formal ceremony as a gift from the alumni to the School of Journalism. The annual alumni dinner will be held this year at Harris' and the dinner program will continue until time to adjourn to the Pi Kappa Alpha house about 10 p. m. for a reception and dance given to all Journalism Week visitors by journalism alumni and former students living in Columbia. The dinner will be a happy relaxation from serious, practical addresses. It is planned as a family gathering of alumni, former students, journalism faculty members, and seniors with time for conversation and reminiscences.

The entire week of May 10 to 15 inclusive is filled with inspirational addresses by experts in every line of journalistic work, and the odd hours are crowded with breakfasts, luncheons, receptions, dances and banquets, with round table discussions, intimate group meetings and opportunities for personal conversations.

Monday will be Missouri Writers' Guild Day, with Mary Blake Woodson of the K. C. Star presiding. The program will include the following talks: "Tips for Feature Story Writers" by Mrs. Frances J. Whitson, Hardin College, Mexico, Mo., novelist and former reader for Little, Brown & Co., Boston; "The Mystery Story," Johnstone McCulley, Colorado Springs and New York, mystery and detective story writer; "The Romance of a Best Seller," J. Breckenridge Ellis, Plattsburg, Mo., novelist; "What a Middle Western Editor Wants from Middle Western Writers," Walter W. The annual Writers' Guild dinner will be held at 6:30 p. m. Monday at Harris'. Decorations and program will be Bohemian. The business session of the Guild will be held Tuesday morning.

Tuesday will be special features day with a program of varied interest. Theta Sigma Phi and Sigma Delta Chi will give a reception following the evening program for all Journalism Week visitors.

Wednesday, Thursday and Friday are Missouri Press Association days. E. H. Winter, president of the association, will preside at the day sessions. The M. P. A. Past Presidents will have their annual dinner in Fulton Wednesday evening, as guests of Ovid Bell, editor, of the Fulton Gazette. Kappa Tau Alpha probably will have its annual dinner Wednesday evening and Alpha Delta Sigma and Gamma Alpha Chi will give a reception from 10 to 12 p. m. that evening.

The Columbia Commercial Club will have its complimentary luncheon for Journalism Week visitors Thursday noon. J. S. Hubbard, executive secretary of the Missouri Press Association, is arranging for a dinner for the Missouri Associated Dailies Thursday evening and it is probable the weekly newspaper publishers will also dine together that evening. This is the evening for the alumni banquet. After all the dinners, everyone will come together for the reception at the Pi Kappa Alpha house.

On Friday the M. P. A. business sessions will be held and the closing function of Journalism Week as well as the most elaborate event, will be the Friday night

banquet in Rothwell Gymnasium—this year a "King Features Banquet" relating to special features, comic strips and other humor carried in modern newspapers.

Missouri Debaters Win From Wisconsin.

Missouri won the Wisconsin debate in Jesse Auditorium April 12 on the question, "Resolved that this house is opposed to the principle of prohibition." Glenn Bell and George Mitchell, Wisconsin, supported the affirmative. Jean Paul Bradshaw and George Wise represented Missouri. More than five hundred attended. Dr. J. W. Hudson presided.

Missouri, represented by Miss Celeste Burgess and Miss Deldee Myrick, affirmative, won the first intercollegiate women's debate to be sponsored by the University on April 22 with Washington University. Miss Freda Heilburn and Miss Gertrude DeWitt represented Washington. Dean F. B. Mumford was chairman. The subject was, "Resolved that the Child Labor Amendment to the Constitution should be ratified by the various States." George W. Hulbert, Debate Coach, deserves credit for the fine showing made by Missouri and the increased interest aroused.



Louis V. Stigall, LL.B. '10, Student President '09, Phi Delta Phi, Attorney of St. Joseph, Mo., member of the firm Sherman, Stigall and Kranitz, was elected Mayor of that city on April 6, receiving one of the biggest majorities ever given a candidate for that office there. Mr. Stigall was formerly city counselor of St. Joseph. He married Miss Adele Vegely in 1915. They have one son and one daughter.

"Reading With a Purpose" Is Offered to M. U. Alumni

Amherst College has a plan furnishing its alumni with lists of books for reading and study. "In the belief that a college should serve its graduates by helping them to obtain the best available knowledge of whatever vitally interests them beyond the confines of their business or professional careers, Amherst College offers its alumni an opportunity to continue systematically, under the guidance of the College, studies begun during, or undertaken since, their graduation years." Amherst sends book-lists with annotations such as: biology leaflets, literature leaflets, and religion leaflets in which two or three books are recommended. The author, title, publisher, date and price, with an outline of the contents of each book is given. The College sends out, outlines of colleges courses, occasional bulletins, and holds conferences at Amherst and elsewhere.

Smith College furnishes her alumnae with reading lists arranged with a view to gradual development. There are no examinations and no reports except to discover the use and value of the plan. The idea as expressed in the outlook for June 14, 1925 is to continue intellectual contact between the college and the alumnae. "It is not a university extension course, no credits toward degrees are offered, no preparation is necessary and there is no correction of papers. The courses are suggestive and voluntary." On the subject of government, there will be readings on international relations, municipal government, and current politics; in economics and sociology, on the labor movement, industrial organization, social maladjustments, and the like. By this plan the college hopes to keep in touch with 2,000 former Smith students in a new way.

The Harvard Alumni Bulletin prints occasional lectures by members of the Harvard Faculty, but no attempt is made to offer reading lists.

The Princeton Alumni Weekly begun two years since to issue and distribute certain college lectures to alumni.

In 1915, The American Library Association began issuing a series of reading courses on various subjects for the convenience of the public. It assumes that a great many people wish to read with a purpose than to read without, to read several books on a subject in which they are interested than to read a book of travel, a book of fiction, a book on literature and a book on history without any connection. It is assumed that the alumni of colleges and universities would be interested in reading along some definite line, or some on definite subject. For this reason, the attention of the alumni of the University of Missouri is directed to these courses. The University is not equipped to supply courses like Amherst and Smith Colleges do, but these "Reading with a Purpose Courses" will serve the same purpose nicely. A book is issued for every course like; biology, for instance. Vernon Kellogg, a well-known authority on biology wrote a brief treatise

—a short book of forty pages giving in a general way the history and progress of biology with an account of six books dealing with the several phases of the subject. The names of the books are:

Thompson, J. A. "Every-day Biology"
Wiggam, A. E. "The Fruit of the Family Tree"

Wheeler, Wm. M. "Social Life Among the Insects"

Kellogg, Vernon. "Evolution."

It is the constant aim in the choice of books to be read to select those that are authentic and readable informational and inspirational, popular and interesting.

The course on the Life of Christ was prepared by Rufus M. Jones. He recommends the following books:

These books may be borrowed from the public libraries or they may be purchased at the book stores. The university library would not be able to meet the demand if it should undertake to lend them. To buy a few books for the home every year, is a good habit, and a profitable investment. In the East students and alumni buy books, in the Middle West they borrow them. The American Library Association plans to issue one number in the course every month. The Missouri Alumnus would print the list of books in the new courses monthly as they appear, if the alumni should be interested to have the list. A list of the courses in "Reading with a Purpose" may be secured from your local public library or from the American Library Association, 86 East Randolph St., Chicago, Illinois, without charge.

DR. J. C. JONES, Director of the Memorial Union and Stadium Campaign, has been assured by Mr. H. H. Carrothers, the Stadium contractor, that the first unit of the Memorial Stadium will be turned over to the Stadium Committee by August 15. Mr. Carrothers and his men have been diligently working on this job both day and night and in all sorts of disagreeable weather, for Missouri has had a real mean lot of weather this winter and spring.

The Stadium site is indeed an interesting one. Where was once this fine hill pasture land which held so much sentiment for the boys and girls who frequented Rollins Spring now you'll find a great hole lined with rock and machinery, with the stadium proportions gradually coming to light. The excavation of this work has been a tremendous task, with tons and tons of rock and clay to blast and move. Hundreds of spectators go to the stadium site during visitors' hours, and every alumnus and Memorial subscriber who comes to town rushes out to see this gigantic work under operation.

"I find that our Memorial subscribers are not looking upon the stadium as merely a place to play football," said Dr. Jones. "They are looking forward to the time when the stadium is completed so that plans will be completed whereby every boy and girl in the University, and the faculty members and returning alumni may participate in sports of all kinds in this huge athletic plant. The idea behind this gift of the alumni and students is to furnish an ideal place for the physical education of the youth of the state, and not merely a football plant. The same spirit prevails about the Memorial Union. The gift in this case is to the students of the University a permanent headquarters and a place for their leisure hours, and a permanent headquarters for the alumni and their organization and a place for them to come when they return to the campus.

It amuses me very much when I hear someone say that the main interest of the alumni toward alma mater is athletics," continued Dr. Jones. "Nothing is farther from the truth. I can say this with every degree of truth for the benefit of the alumni of the University of Missouri. Their interest is of a constructive sort for the University. They want to do something really worthwhile and big for alma mater. They have organized on a basis that will bring extraordinary benefits to the University in the years to come. They have a force for strength that is being developed in splendid fashion and they are responding in a manner far beyond expectations. Their gifts toward the Memorial Union and Memorial Stadium are just mere steps to the big things that they will do."



THE MEMORIAL UNION AND STADIUM CAMPAIGN office force is devoting most of its time and effort now to the collection of Memorial payments. Last month we spent most of our time with the Student Campaign, which netted \$87,000 in pledges and sufficient cash to pay the expenses of the campaign.

There are a few counties in Missouri and a few cities outside of the state where campaigns are yet to be held for Memorial Union and Stadium subscriptions. Most of our time from now on, however, will be spent in collecting the pledges. This is a tremendous task. We have approximately nine thousand subscribers, whose pledges are copied on cards in our office. Each subscriber owing a payment receives a statement each month, until he pays up. The addresses of subscribers must be kept as accurately as it is humanly possible. You can realize it costs lots of money to handle these collections, and especially so if many subscribers do not pay promptly. The book-keeping, printing, postage and clerical help mean dollars.

On the basis of the pledges made, and on the strength of our faith in the loyalty of the subscribers, four contracts for as many units on the Memorial Tower have been let. The cost of these has been met, with the exception of a payment due on the third unit, recently completed. The contractor, the B. D. Simon Construction Co., of Columbia, is carrying for us what you owe him. If all who owe would pay all or part of what they owe at once we could pay Mr. Simon what we owe him on this third unit. We are counting upon your loyalty to send us at once what you owe, for we must not break faith with our dead heroes, to whom we are erecting this Memorial. We must also keep faith with Mr. Simon, who has taken the contract on the fourth unit because he believes in your loyalty and in your fidelity to your pledge.

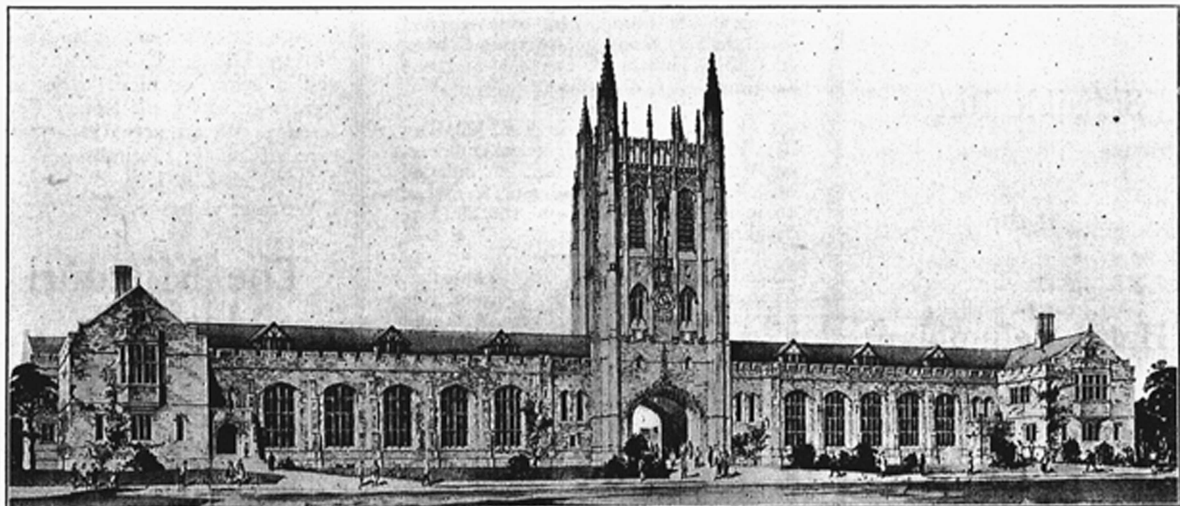
If you will pay promptly we can complete the Tower and dedicate it this fall.

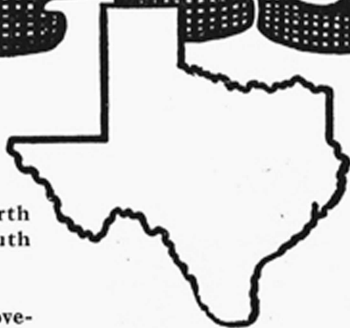

President Brooks says: "Unless many men and women of vision come to the rescue of both state and endowed colleges with liberal contributions higher education will be confronted with perilous times."
