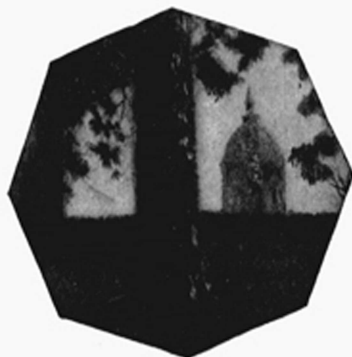

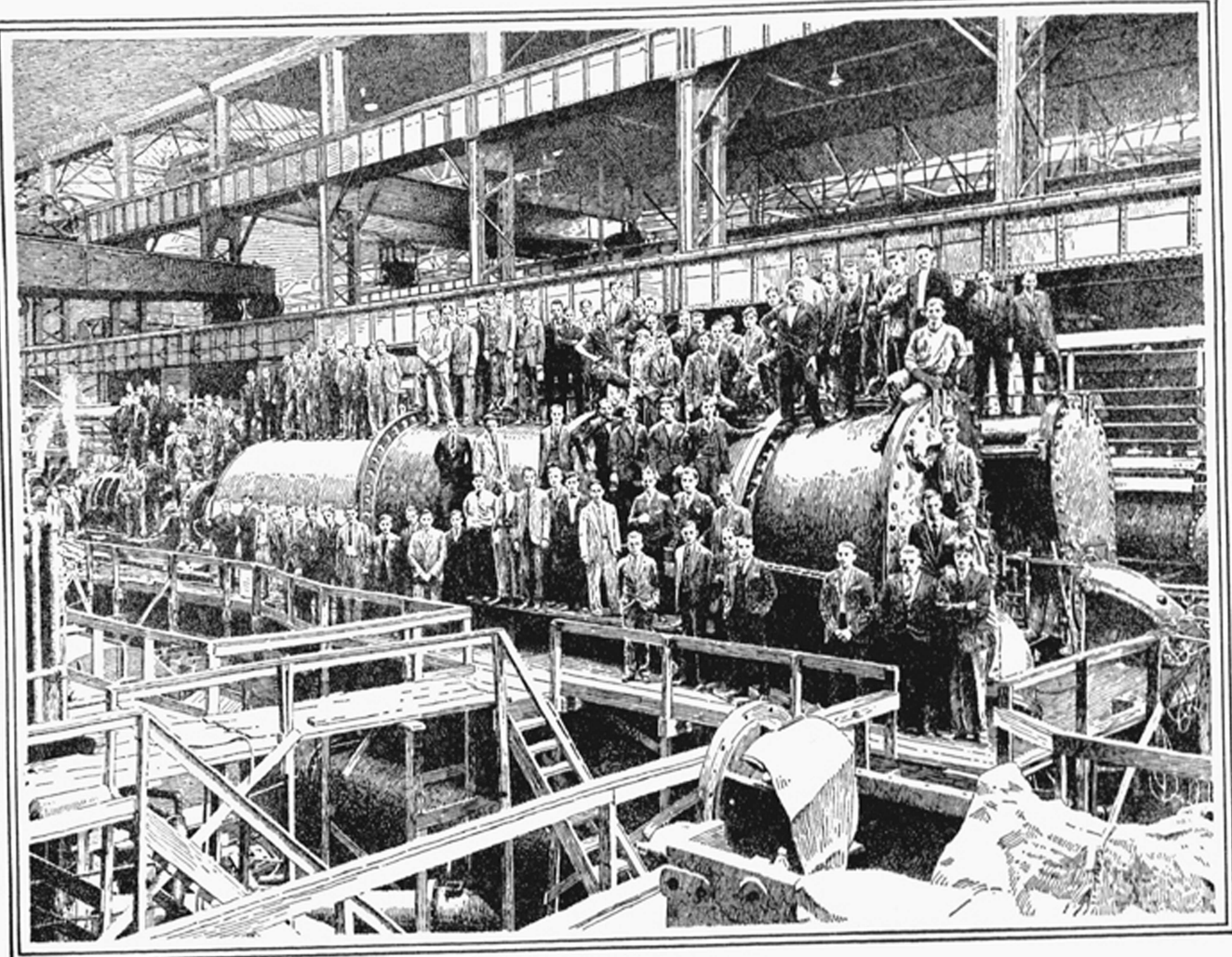

THEODORE GARY TO HEAD STATE SURVEY

Governor Caulfield has announced the names of the commission to survey the needs of the state penal, eleemosynary, educational and governmental institutions of Missouri. The members are Theodore Gary, Kansas City; Fred Naeter, Cape Girardeau; Senator William R. Painter, Carrollton; Senator Manvel H. Davis, Kansas City; Claude B. Ricketts, St. Louis; Langdon R. Jones, Kennett, and Alvin McReynolds, Carthage.

The commission was created by an act of the present legislature at the urging of Governor Caulfield in his inaugural address.

Ricketts and Jones are members of the house of representatives.

Gary, a Republican, who is chairman of the commission, was chairman of the state highway commission during the administration of former Governor Hyde and part of former Governor Baker's administration, and was prominent in the promotion and administration of the \$60,000,000 road bond issue. He is a telephone magnate.

Naeter is a newspaper publisher and a Republican whose newspaper the Southwest Missourian is housed in one of the most complete and modern newspaper plants in Missouri outside of the big cities.

Senator Painter, a Democrat is publisher of the Carrollton Democrat. He has been lieutenant governor, a candidate for governor, head of the prison board, and has held other offices in the state.

Senator Davis, a Republican has served two sessions in the Missouri house of representatives and was elected to the senate in 1928.

Representative Ricketts, an office building operator of St. Louis, is a Republican. He is president of the Railway Exchange Building, Inc., and a member of the Transportation Survey Commission of the city of St. Louis, which is working out a rapid transit program for the city.

Representative Jones, a lawyer is a Democrat and is serving his first term in the house of representatives. He has been active in floor control work.

McReynolds, a Carthage lawyer is a Democrat and was a member of the citizens road bond committee which sponsored the \$60,000,000 road bond issue.

The commission is expected to survey the state institutions with a view toward recommendations as to needed improvements, additions or changes. Its powers are wide in scope and its recommendations will be made to the governor who in turn may call a special session of the legislature to act upon them.

DR. PICKARD RETIRES

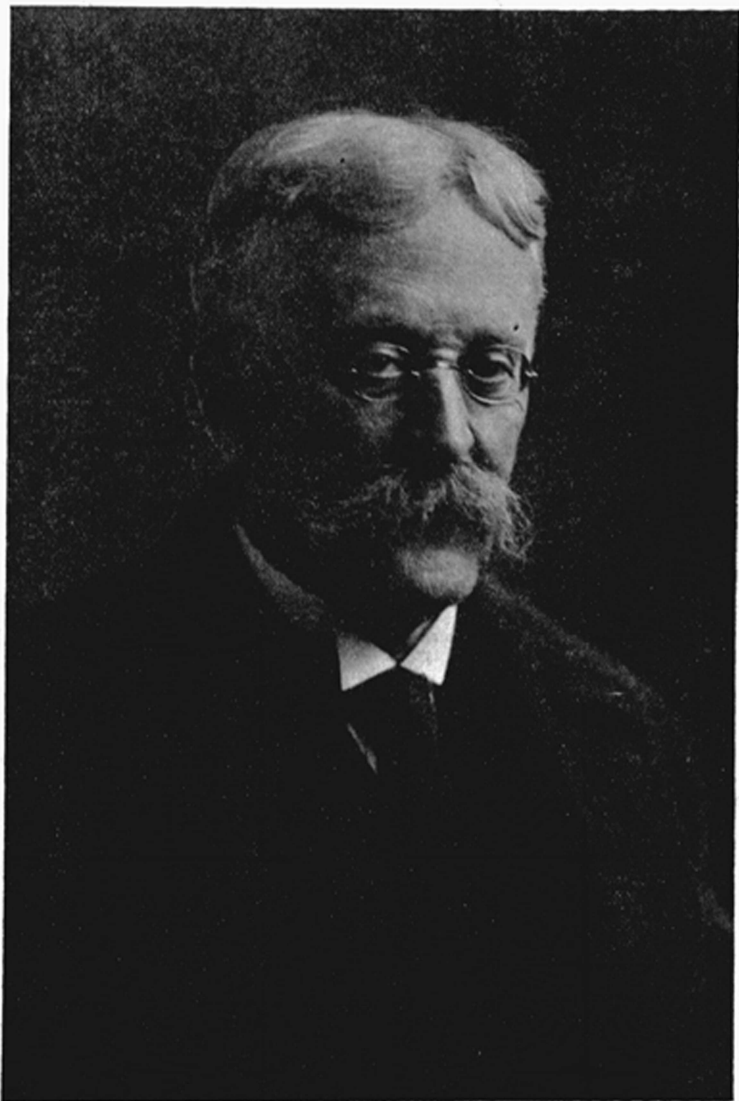
On May 1, 1929, having been a teacher for fifty-four years and having given thirty-seven years of devoted service to the University, Dr. John Pickard became Professor Emeritus of Classical Archaeology and the History of Art in the University of Missouri.

Dr. Pickard was born in Concord, New Hampshire on October 12, 1858, son of Samuel C. and Clara (Moore) Pickard. The Pickards have the somewhat rare distinction of being one of the few "first families" of New England whose ancestors did not come over in the Mayflower. The name is of French origin but as constituted at present English, Scotch and Irish blood also flows in the veins of this family.

Dr. Pickard obtained his preparatory schooling in the public schools and academies of his native state and received his A. B. in 1883, his A. M. in 1886 from Dartmouth College, ranking among the "first three," of his class.

He married Jeanie Austin Gerrish of Portsmouth, New Hampshire, in 1889. They have one daughter, Caroline Gerrish Pickard, now an artist in Taos, New Mexico.

After years of successful teaching he went abroad in 1889 for study in the Universities of Leipzig, Berlin and Munich and in the American Schools of Classical Studies in Athens and in Rome. He re-

ceived the Ph. D. Degree "Magna Cum Laude" in the University of Munich in 1892, in the three subjects, Classical Archaeology, Classical Philology, and the History of Art. Since that time he has been abroad many times for study in the great Universities, museums and Art Galleries.

In 1892 he came directly from Munich to the University of Missouri as Assistant Professor of Greek. Within three months another great University called him but the Board of Curators persuaded him to remain in Missouri by creating the Department of Classical Archaeology and placing him at its head. This department was later extended to include the History of Art. In connection with his work he established and equipped the Museums of Classical Archaeology and the History of Art.

Besides his distinguished work as the head of his department Dr. Pickard has found time to render much valuable service to the University and the University community.

He is president of the University club Building Association and Chairman of the Committee which built the Club House. He was chairman of the Committee which built the Y. M. C. A. building. He is president of the Association and is largely responsible for building the beautiful new house for the Acacia Fraternity. He is

now active in securing funds for a splendid DeMolay Home at the University.

At the close of the World War it was Dr. Pickard who suggested a Memorial to the University men who went to the war. He is vice-president of the "Committee of Nine," having this project in charge. The Architect declares that to Dr. Pickard more than to any other one man is due the credit for "the most beautiful Gothic Tower in America," which now stands on the East Campus of the University.

Largely through his efforts, also, beautiful bronze reliefs in honor of Major Rollins and the first president of the University will be placed at the north entrance of Francis Quadrangle at the forthcoming Commencement.

Dr. Pickard served two years as Dean of the Department of Arts and Science and was Chairman of the Committee which established and for several years had charge of the Graduate Department of the University. He has also since the first appointment of this Committee been chairman of the committee on Honorary Degrees.

He was chairman of the Committee that organized the University's great exhibit at the Louisiana Purchase Exposition, and at the close of the Exposition brought

back to the University twenty-seven car loads of valuable apparatus and furnishings.

At the request of President Jesse he formed the plans and established the University's Cooperative Store and is still its President. It is a very moderate statement to say that this store in the nearly thirty years of its existence has saved to the students of the University more than half a million of dollars.

He is a member of Phi Beta Kappa, of the American Philological Association, of the Archaeological Institute of America and has been president of the Missouri Society of the Institute of the College Art Association and was its president for five critical years in its development.

In Free Masonry his career has been remarkable. A mere enumeration of the Grand offices he has held will show the rapidity of his advancement and the esteem in which he is held by the members of this order.

He has been Grand Patron, O. E. S., Grand Master of the Grand Council, Grand High Priest of the Grand Chapter, President of the Order of High Priesthood, President of the Post Commanders Association of the Knights Templar, Grand Master of the Grand Lodge. He is now Chancellor of the Imperial Council of the Red Cross of Constantine.

In Scottish Rite Masonry he is a 33rd degree Mason and has been Venerable Master of the Consistory of Western Missouri. His fame as a great ritualist has spread not only through this state but among all Masons through the nations.

Apart from his labors at the University the most distinguished service he has rendered to Missouri has been his work as president of the Capitol Decoration Commission. For the past twelve years this commission has been engaged in the arduous undertaking of decorating Missouri's new capitol. More than a million dollars has been expended on these works of art. The decorations of the Missouri State Capitol are in a class by themselves and will in the coming years stand as an enduring monument to the labors of this commission.

The report of the Commission written by Dr. Pickard is a model of clearness and artistic perfection.

The suggested form follows: "I hereby give, devise and bequeath to the Curators of the University of Missouri, as trustees, the sum of \$..... to be used by the Curators according to their best judgment for some necessary or desirable purpose in connection with the conduct of the University of Missouri at Columbia, Missouri." (Should it be desired to name some specific purpose for which the Curators are directed to use the bequest such purpose may be indicated in proper terms.)

There are many equally dear whose names do not come back to me. I know of but two students now living that graduated from the University prior to that time. They are Col. W. W. Stone of Mississippi and T. B. King of Texas. It would be a great pleasure for me to meet with you at a social function with my dear friend, Dr. Miles, whose presence here brings up memories of the past. He and I are about the same age. Extend to him my heartiest congratulations."

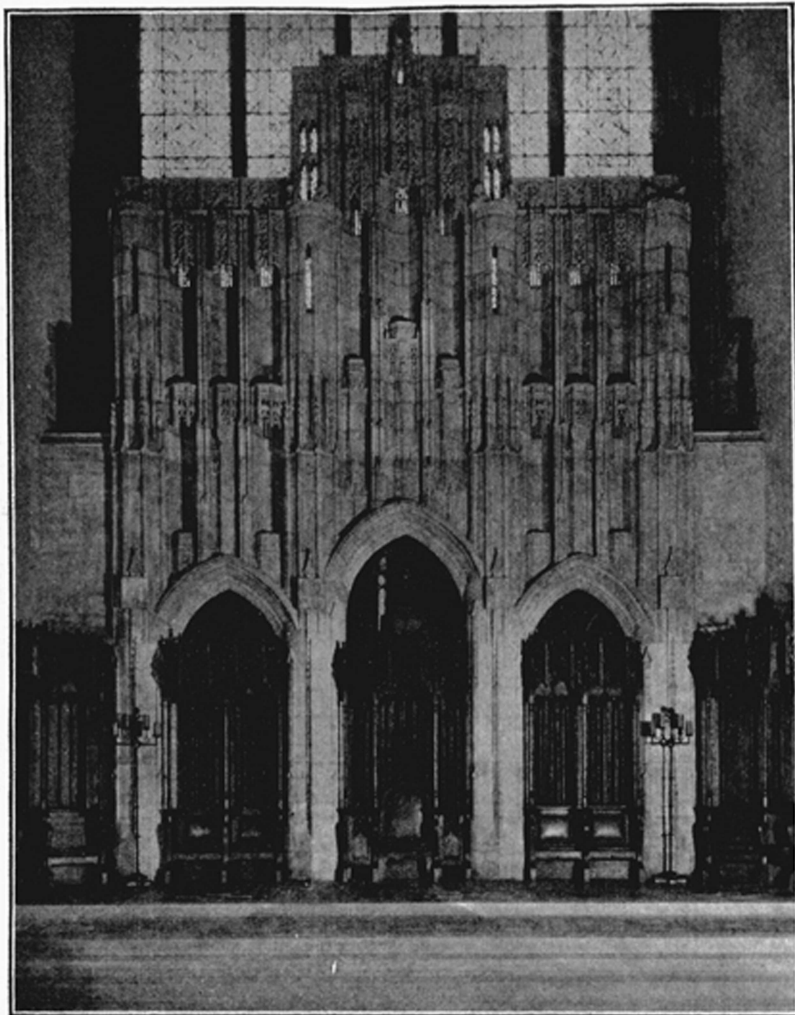

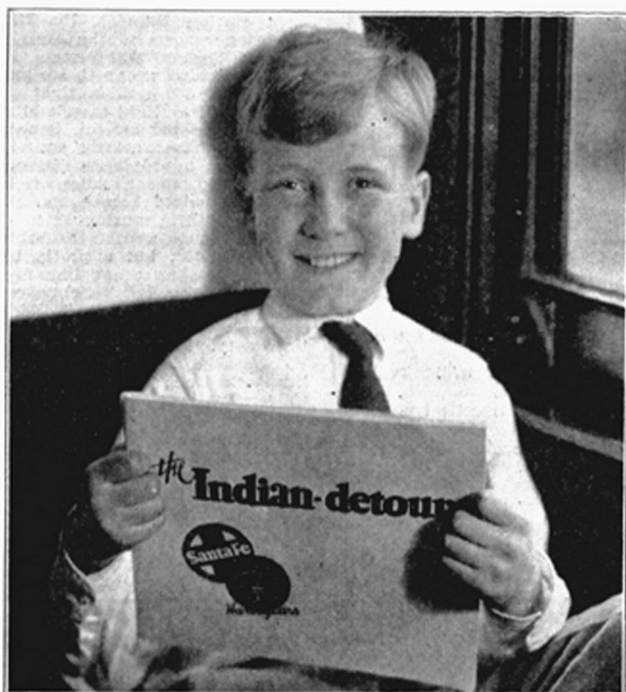

Welcome to Colonel Wright, Who Succeeds Colonel Kerth

Col. John Womack Wright, who will succeed Col. M. C. Kerth as commandant of the R.O.T.C. unit of the University at the close of the present semester comes here with more than thirty years experience in the U. S. Army.

Col. Wright was born in St. Louis in 1876 and was educated in the public schools and at Columbia Academy, District of Columbia. He also attended William and Mary College and George Washington University. He was a member of Phi Beta Kappa and Kappa Sigma fraternities and received an LL.B. at George Washington University in 1898.

In 1898 he joined the U. S. volunteers for the war with Spain, serving in Cuba from August 1898 until 1902 and in the Philippines from 1902 until 1903. From 1906 until 1909 Col. Wright served as chief of the military information division with the Army of Occupation in Cuba, and in 1912 became a member of the general staff. He was also a member of the Pershing Expedition to Mexico, and from 1918 to 1920 served on the general staff of the A. E. F. and as assistant chief of staff G-3.

Col. Wright was with the historical section of the Army War College for three years, and on special duty with the Budget for one year. Since 1924 he has been commanding the 5th Infantry at Portland Harbor, Me. Col. Wright was awarded the Distinguished Service medal and is also an officer in the Legion of Honor. He has served in all ranks of the regular army from second lieutenant to colonel.

He compelled "Road Notes on Cuba" published by the general staff in 1909, was the author of "Organization of the Service of Supply of A. E. F." published in 1921, and co-author of "Warfare" which was published in New York in 1925. He was also a contributor to the Dictionary of American Biography, the American Historical Review and other publications and is a member of the American Historical Society, the Maine Historical Society, and the Society of Cincinnati.

A Timely Reminder.

The members of Mortar Board, QEBH and Mystical Seven are to be commended for the steps they have taken to impress upon their fellow students the significance of the Memorial Tower and the reverence that should be attributed to it. They have distributed the following resolution:

"The Memorial Tower was erected as a perpetual tribute to those heroic martyrs who so unselfishly and unflinchingly made the supreme sacrifice. That their undying devotion might not be unheralded, to be straightway forgotten by the treacherous memory of man, the student body of the University of Missouri raised this magnificent monument. It should be forever enshrined in the heart of every true and loyal Missourian, in the same manner and to the same extent as are the venerable, ivy-covered Columns.

"Out of respect for the fine and noble sentiments and traditions of which the Tower is symbolical, we students should zealously avoid committing all acts of desecration. The heart of every student should be imbued with a sense of deep and profound reverence that will make him vitally alive to his obligations, and wrench him away from a mere pretension that is all too often attributable to inertia and habit.

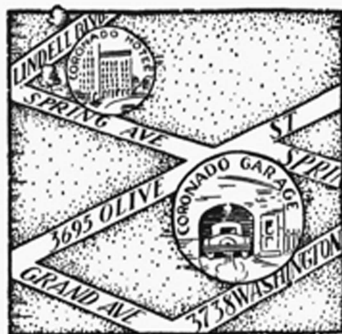

Rum, Romanism, Rebellion



In 1884 it was James Gillespie Blaine, "Plumed Knight" to millions of Republicans, versus indomitable Grover Cleveland, Democratic governor of New York. The campaign had been one of vilification; there were low insinuations regarding Blaine's honesty; there was base political use of undeniable unconventionalities in the private life of Grover Cleveland. Towards November it became evident that the election would be won or lost by the electoral vote of New York. Less than a week before election day, Blaine came to Manhattan, put up at the Fifth Avenue Hotel. As *TIME* would have told the story had *TIME* been issued November 4, 1884:

... At ten a. m. the delegation of six hundred grim Protestant clergymen arrived in mass formation before the hostelry. Cigar-chewing politicians made way for them as they trooped in, to assemble in the ball-room. A waggish fellow hissed loudly from the balcony, was speedily ejected. Viva voce they chose as chairman 72-year-old Rev. Dr. Samuel Dickinson Burchard, square-jawed, militant pastor of the 13th Street Presbyterian Church. He appointed a committee to seek Mr. Blaine in the lobby. Soon it returned, escorting the candidate and members of his family down the ball-room steps. Dr. Burchard ascended to their side, amidst clerical applause, and spoke: "You

see here a representation of all denominations of this city. . . . We are your friends, Mr. Blaine, and notwithstanding all the calumnies in the papers that have been urged against you, we stand by your side. We expect to vote for you next Tuesday. . . . We are Republicans and don't propose to . . . identify ourselves with the party whose antecedents have been Rum, Romanism and Rebellion. . . ."

At these words the Plumed Knight started perceptibly and a look of pained surprise flashed over his mobile features. The assemblage applauded wildly. Casting about for a fitting rejoinder, Blaine soon seemed to forget. Other preachers preached, fulsomely, with bombast. A superannuated divine fainted and was carried out. Finally, with vigorous urbanity, the candidate replied, neatly sidestepping a pro-Protestant declaration, but letting Bigot Burchard's impertinent alliteration pass unrebuked.

That night the partisan press rang with mendacious assertions that Blaine had insulted Democracy, that Blaine had deliberately approved Bigot Burchard's denunciation, that Blaine would now lose Manhattan's anti-Cleveland Catholic vote previously conceded him. . .

So *TIME* would have reported the "Burchard business" of 1884. *TIME* would have noted how the "Rum, Romanism, and Rebellion" phrase stuck like pitch, gave Grover Cleveland New York's electoral vote, and so the Presidency, by a bare margin of 1,149 ballots.

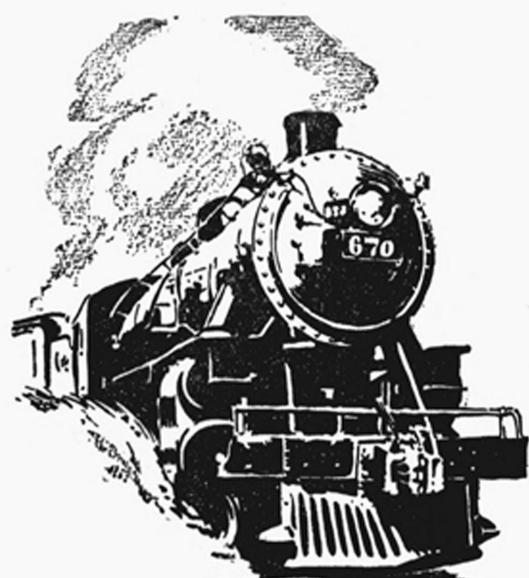
