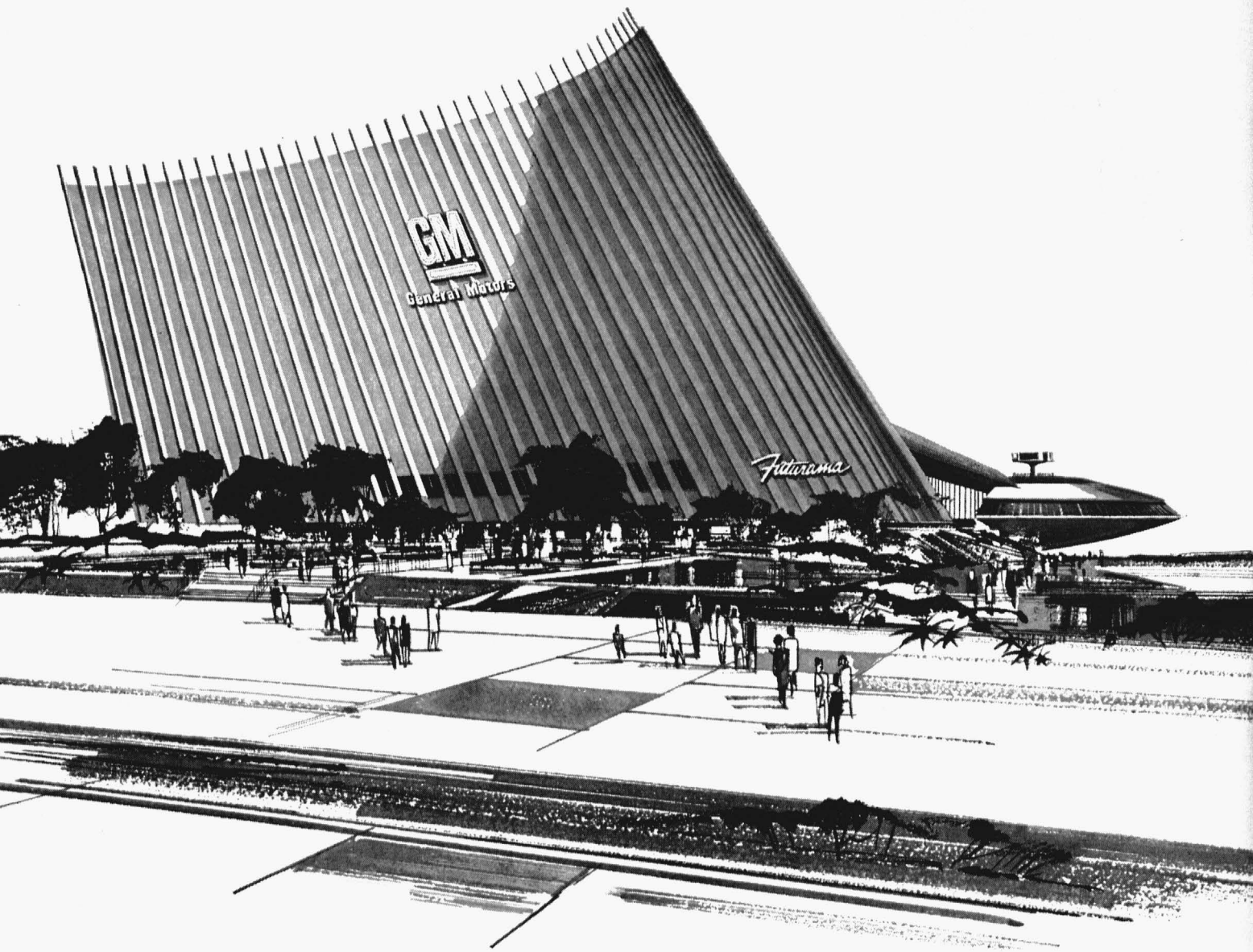

Campus Computers

The computer has come to the campus in considerable force and is destined to increase in number. Working overtime is a battery of these problem-solving and time-saving mechanisms which are accelerating many activities of the University. The activities include business transactions, the compiling of student records, circulation of library books, medical diagnosis, Extension Division service to farmers across the state, and research in many areas.

On any day, one might find in the University's Computer Center a group of graduate psychology students calculating results of behavior studies with mice, monkeys, and men; undergraduates in special physics and mathematics doing problems assigned to emphasize the computer's usefulness; and agricultural economists finding out which crops are making money for farmers enrolled in the Extension record-keeping service. In addition, several faculty members may be absorbed in setting up their own research problems.

The IBM 1620, a small scientific computer, located in the Center's quarters in the B & P A Building, and another in the new Geology Building, are each at

work more than eighty hours a week, on an 8 a.m. to midnight schedule. Their services are being used primarily by seven schools and colleges on the Columbia campus, with 49 departments conducting about 250 projects a year. Hundreds of faculty members and graduate students, and some undergraduates, are using the facilities.

The Center's staff of eleven full-time and six part-time employees is at the service of the entire University, operating under the Dean of Research Administration, Dr. Raymond E. Peck. Computer costs are paid through that office or from special grants or project funds.

Dr. Roy Keller, director of the Center, coordinates computer use for basic research problems. There are a number of consultants who are staff members of University departments. Also on the staff of the Center are an assistant director; a senior research analyst; supervisor of systems, operations, and of mathematical and statistical computing; programmers; and stenographers.

In the Computer Center is a library of more than



120 programs for solving various types of problems. Hundreds of programs may be ordered through a users group cooperative arrangement, or directly from the manufacturer.

In addition to the computers of the Center, there are four others in operation on the Columbia campus: two IBM 1620s at the College of Engineering; an IBM 1410 at the Medical Center; and an IBM 1401 at the Data Processing Center on Stewart Road.

In the College of Engineering, the two 1620s are at work under the direction of Dr. James W. Baldwin, associate professor, along with seven smaller analog computers for student use. Students from thirty engineering courses use the computer as a tool. Last semester more than 25,000 student problems were processed.

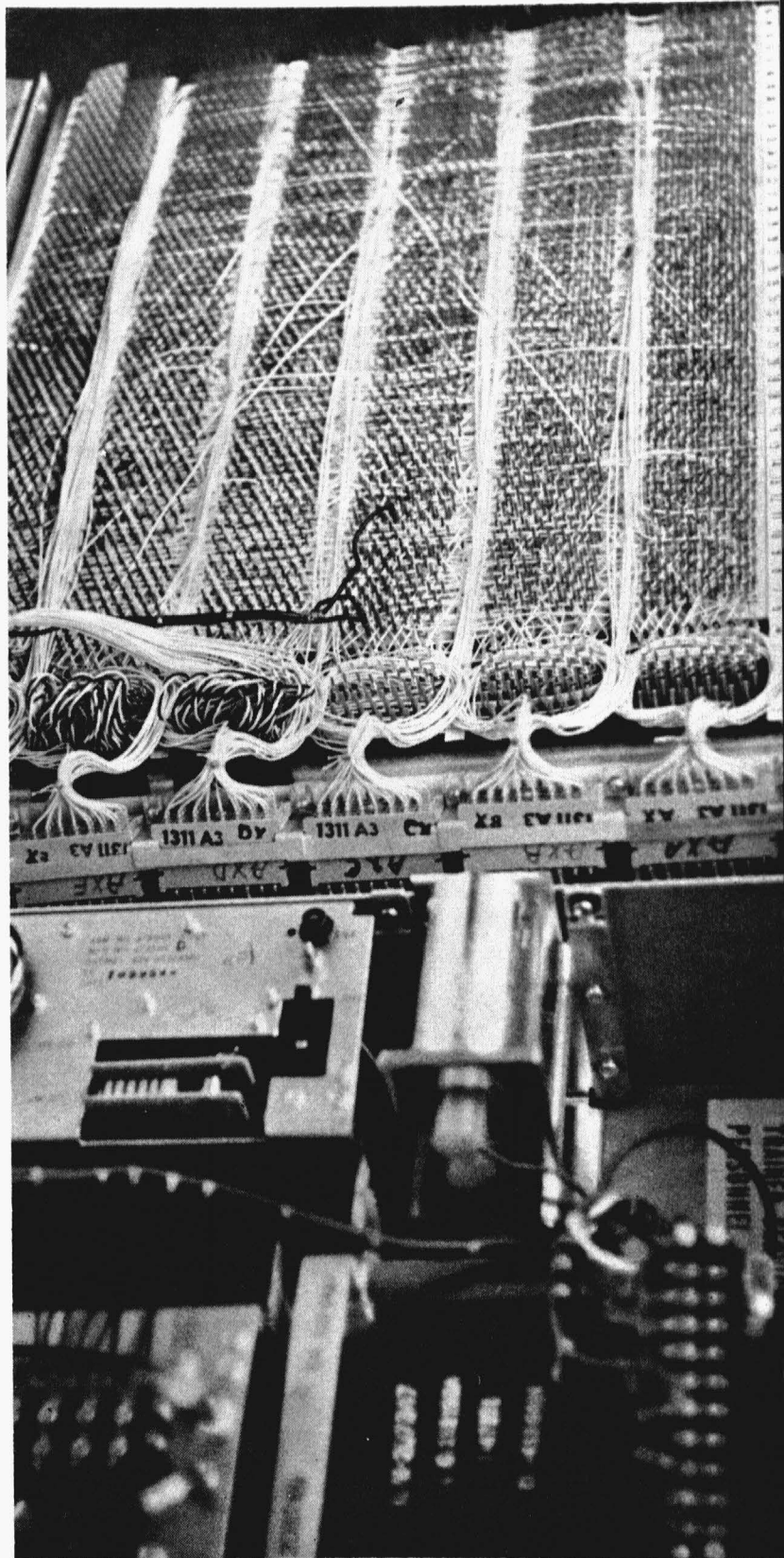
Current research in engineering includes a study on the strength of various types of bridge stringers, and several studies are under way in computer control and operation of machines in manufacturing. Cooperative studies on brain waves are being carried out with the psychology department. This research computing is scheduled through the Computer Center office.

The computer program at the Medical Center, which is serving in many ways as a national pilot program in medicine, is directed by Donald Lindberg, M.D., assistant professor of pathology. There the records of more than 70,000 patients cared for there since 1955 are being stored. The computer's "memory" is a file of disks holding 28 million letters or numbers. Through remotely-controlled typewriters, these records are immediately available to researchers, to students in the Medical School laboratories, and to physicians considering all likely diagnoses for current patients.

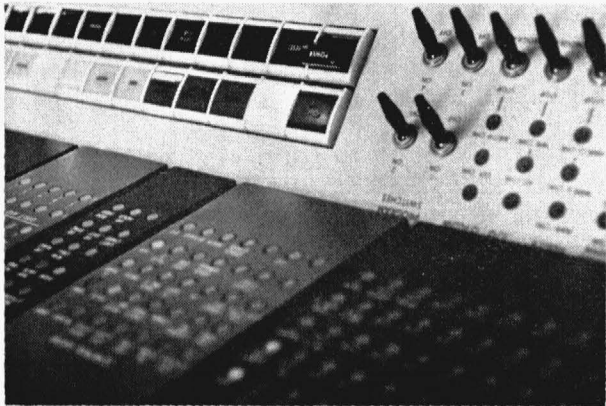
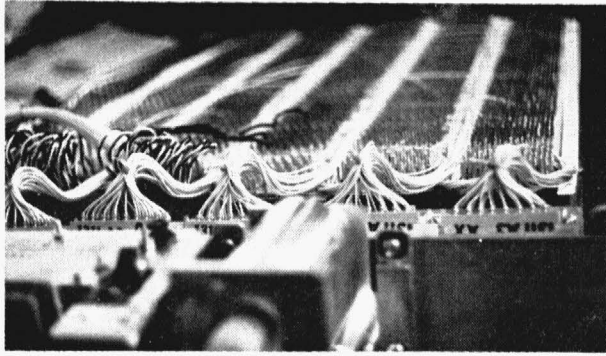
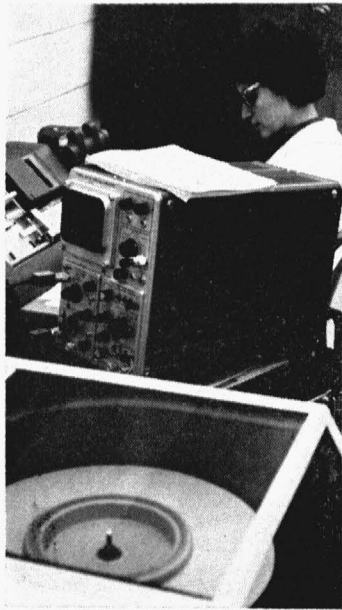
Research at the Medical Center into the use of computers in the diagnosis of bone tumor has been assured two more years of support from the National Institutes of Health with the award of a renewal grant of \$26,887. Grants that began in 1962 totaled \$47,454 through 1964. The research is being conducted in the Department of Radiology under the direction of Dr. Gwilym S. Lodwick, professor of radiology and chairman of the department. An exhibit of radiological computer research on bone tumors prepared by Dr. Lodwick recently received a special award at a meeting of the Radiological Society of North America. It was the first Society demonstration utilizing a computer.

Even before problems and their programs can be used by computers, the two sets of information must be converted into a numerical code. This is done by a person operating a key-punch machine which codes alphabetical and numerical symbols into a 3x7 inch card with space for 80 symbols. Complementing the computers and essential to their operation are these key-punch machines; verifier machines to check on the accuracy of the punching; sorters which match cards, by perforations, in thousands of ways; and readers, to type back into conventional language and numbers all information on the cards going into and out of the computers.

The Data Processing Center has the largest concentration of these machines. A full-time staff of 55 per-

sons uses about 13 million of the IBM cards a year. Several offices and departments on the campus have their own card processing machines. Among them are the athletic office, the psychology, soils, and rural sociology departments, and the testing and counseling service.

One most recently recognized use of the data processing here is by the University Library which has gained international attention for the special techniques it has developed in ordering, accounting, and book circulation. A program now under way will convert all current processing of library materials to computer processing, and will prepare a program for recording the regular receipt of many thousands of periodicals. Some fifty librarians have viewed the Library data processing operations here in the past year.

The overall range of the several hundred computer projects in progress is nearly as broad as the University's academic program itself. Other projects of interest are those in which gains for retail businesses are simulated, and the structure of atomic nuclei is precisely determined. Still others have to do with de-

termining how long it will take to construct a building, with calculating the energies of crystals, with assisting in the designing of artificial human heart systems, and with systematically documenting changes affecting quality in growing swine, sheep, and cattle.

A new field in journalism research is measurement of public opinion and concepts by factor analysis, directed by Dr. William Stephenson, Distinguished Research Professor of Advertising. Courses presenting this method of research are among several new ones now offered in various schools.

The Computer Center was actually organized in the spring of 1959, with the purchase of a Burroughs 204, and began full operation early in 1960 in two large rooms of the ground floor of the B & P A Building. In 1962, with the Center's workload doubling, an IBM 1620—capable of making 10,000 additions a second—was added.

In discussing future plans for computer use, Dean Peck says he hopes to acquire another computer, larger than the 1620, during the coming year. There is already a backlog of research problems, particularly in physics and engineering, too time-consuming for the present machines. Another objective is the consolidation of computer facilities in a mathematical sciences building.

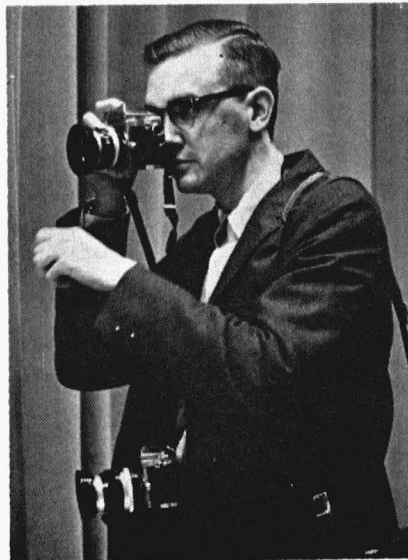
missouri memo

'24, of Cincinnati; and Dr. BENJAMIN R. SHORE, A.B. '20, of Los Gatos, Calif. Young Brownlee also recently became the first fourth-generation initiate of his social fraternity (Sigma Nu).

LT. DENNIS FALCONER, B.S. in Home Economics, '61, is dietitian at Carswell Air Force Base hospital in Fort Worth, Tex. He and his staff of 45 turn out about 1,150 "nutritionally interesting, well balanced" meals at a cost of \$1.03 per day for each person from raw recruit to generals. As director of the dietary program for several hundred persons, he says even the "Fat Boy" crash program menus for flying personnel can be appetizing. "Anybody can get along on 1,000 to 1,200 calories a day and function efficiently," he says. "But they have to be nutritionally interesting, well balanced calories. Variety is the key to successful dieting." Lt. Falconer, who is from Sibley, Mo., is married to a Missourian; she teaches home economics in Fort Worth public schools. He served his internship at a hospital in St. Paul, Minn. and received a direct commission into the Air Force in 1962. Commenting on his choice of home economics at the University, Falconer said: "I was the only fellow in a class of 55. What's so dumb about that?"

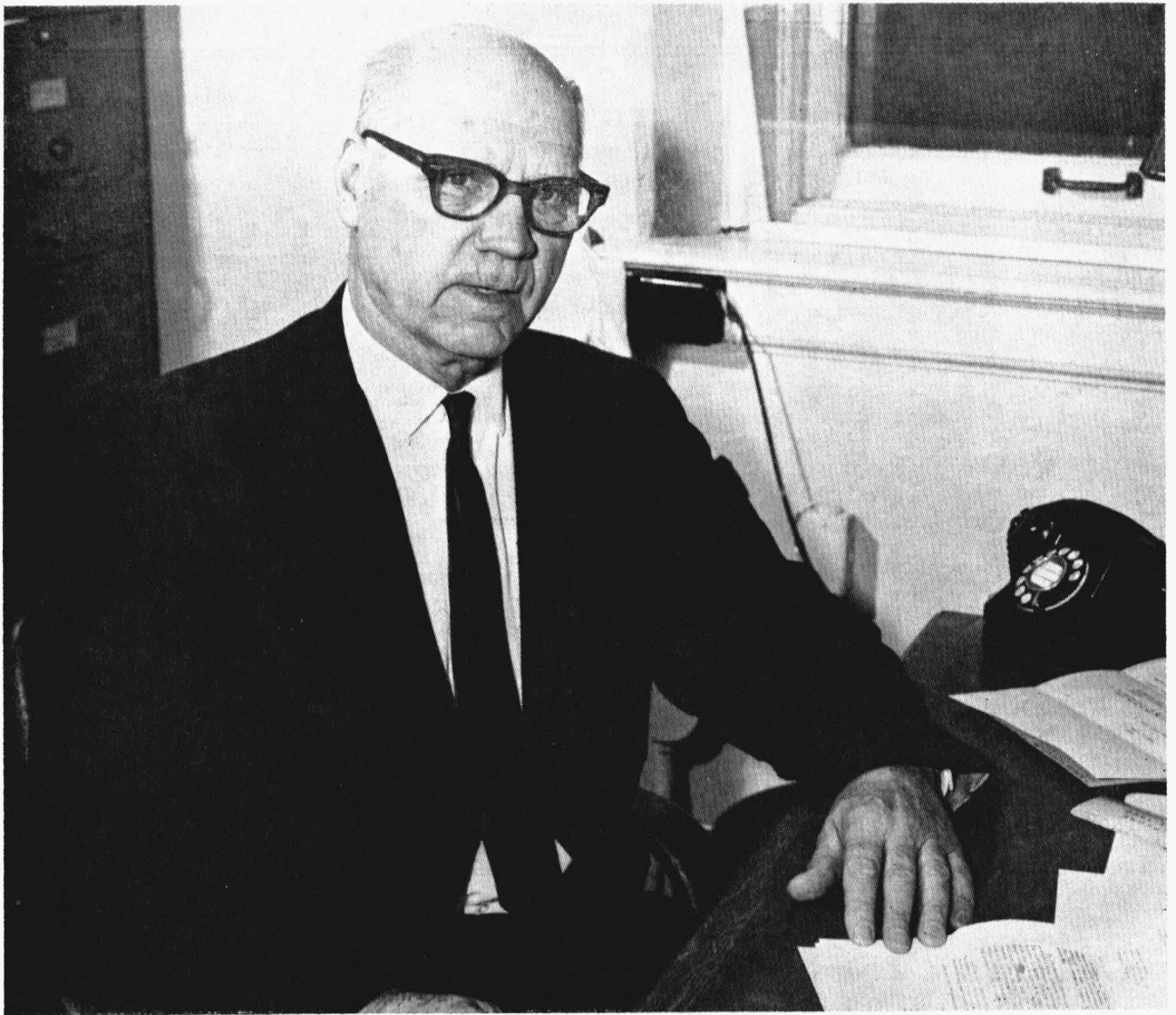

Another University graduate who chose a home economics field and is enjoying his work in the service is JERRY KNOLL, who majored in interior design and took his degree last June. He is teaching in an Army arts and crafts center in Germany after a training period in Heidelberg. In a note to School of Home Economics faculty he wrote, "I have people doing everything from building furniture, casting jewelry to oil painting." He has taken up the study of German at a university near his post in southwestern Germany.

A recent issue of Navy Times tells of the many talents of Dr. (Lt.) ROBERT J. KELLY, A.B. '53 and an honor graduate of George Washington medical school. An applicant for the National Aeronautics and Space Agency's astronaut program, Lt. Kelly was selected for training at the Navy's test pilot school at Patuxent River, Md., the second physician ever to be selected. He is assigned to a test and evaluation project in air-to-air missiles at Pt. Mugu, Calif. After leaving M.U. he became a carrier pilot in the western Pacific. With 2,400 flying hours and 120 carrier landings, Kelly as a physician, jet pilot, flight surgeon and test pilot presents a unique combination of talents for the nation's space program. He is married and has a son and a daughter.

Herb and Stan Retiring

They'll Be Missed

Two of Rothwell Gymnasium's most distinguished senior citizens—Dr. Herbert Bunker and Prof. Anton J. Stankowski—sever long-standing ties with the University of Missouri on July 1. Their retirement will terminate some 45 years of identification with M.U. as outstanding athletes, coaches and teachers in physical education. Dr. Bunker also served for five years as director of activities for the University of Missouri Alumni Association.

Stankowski has reached the mandatory age of 70, while Bunker at 68 is stepping down one year ahead

of his terminal date as chairman of the Physical Education department.

The real old-timers will recall these contrasting Mutt-and-Jeff types with considerable nostalgia. Invariably, old-guard "M" men, back on the campus, would seek out "Stan" or "Bunk" in their P.E. offices—and be rewarded with a reminiscing visit.

These, indeed, were two authentic heroes out of Mizzou's athletic past . . . separated by just a few years in their active playing days. Stankowski came first, along about 1915, and the feisty quarterback out

of St. Joseph quickly earned the sobriquet of "tough, little Polack." He was an all-Valley first-team selection, and a near-indestructible leader until lost with a broken leg against Nebraska late in his senior year.

Bunker cut his collegiate swath in the early 20's—and what a furrow it was! The young giant from Nevada, Missouri, 6-3 and 200 pounds, finished as one of just two four-sport lettermen in the Tigers' athletic annals—and more significantly, was a Phi Beta Kappa scholar to boot. "Bunk" competed in football, basketball, baseball and track—a feat duplicated only by another contemporary, Dr. Johnny Knight of Kansas City.

That's the way it was then. Stankowski played baseball and basketball, too. Good athletes went around-the-clock. Today the all-purpose athlete in college is almost extinct.

How does Herb Bunker compare his era with the present day?

"The basic difference now is specialization," says the Helms all-American basketballer. "Modern coaches

want every player to reach his full potential because competition is so much more demanding.

"This would be my only criticism of the existing system. Does not the athletic scholarship make the player a bond servant to his coach?"

Bunker recalls how Bob Simpson, track coach, borrowed him from baseball to compete in two meets on the West coast. Simpson needed a shot-putter and the burly "Bunk" delivered by winning points against both Occidental and California U. at Berkeley. On temporary duty with the track squad, Bunker stayed the full season after Brutus Hamilton, M.U.'s Olympic decathlon star, injured an ankle at the Drake Relays.

A center and tackle in football, a peerless rebounder in basketball, and a catcher-outfielder in baseball, "Bunk" was a huge hunk of athlete in his time. Only twice during his grid career was he out-sized by an opposing player.

By contrast, Stan was a fiery flyweight at 5-6 and 135 pounds—but a 60-minute warrior none-the-less.

Both were football captains, Stan in '19 and Bunk in '22.

Stankowski's coaching apprenticeship was spent at Central High in St. Joseph, while Bunker was more of a rover. Stan returned to his alma mater in 1926 as freshman coach and promptly inherited the job of intramural director as well. He served under both Gwinn Henry and Frank Carideo, survived both regimes, and handled the varsity baseball coaching assignment briefly before yielding it to John (Hi) Simmons in 1936.

Bunker coached the M.U. freshmen, then moved to Auburn and the University of Florida for one-year hitches, before returning to the Kansas City school system for two years. He then directed the athletic program at Culver-Stockton and coached all sports for nine years prior to rejoining the teaching and coaching staff at Missouri in 1937.

As a Tiger aide, Bunker worked with the "B" team in 1937 under Don Faurot, moved up to the varsity staff as a line coach with Phil Bengston the next year and held that job after Bengston's departure through the 1945 season. Altogether, Herb was identified with three Mizzou bowl teams—Faurot's 1939 and 1941 Big Six champions, and C. G. Simpson's 1945 titlists. From 1946 through 1950, Bunker was the first administrative appointee from within the University to serve as director of Alumni Activities.

Yielding the alumni reins to his assistant, Bus Entsminger, he returned to teaching in Physical Education and has been chairman of that department since George Edwards' retirement three years ago.

Bunker rates the 1941 Sugar bowl squad as the greatest Missouri football team he's seen here.

"They outclassed everyone with their depth and power. I'd say that Dan Devine's 1960 team ran 'em a real close second."

Stankowski, of course, coached M.U. freshmen for ten years, but has devoted 40 years to supervision of the University's intramurals program. More than one colleague has paid Stan the supreme compliment for his work with countless thousands of Mizzou students—"he has lived the job."

Best remembered by his players as a gruff, sharp-tongued martinet who could deflate the high school hero with a caustic remark, Stankowski has mellowed with the passing years. He coached as he played—for keeps. Once irked by a sloppy tackling drill, Stan met the next ball-carrier—a big, rawboned fullback—head-on with a savage tackle and knocked himself stiff.

His record file on former players and intramural participants is amazingly complete. Often a news story about an M.U. graduate will ring a bell in the old coach's alert mind, and a quick check of the records will establish the individual's athletic background.

Still retaining a keen interest in Tiger athletics, Stan regularly stops by the coaches' office on his rounds to compliment them for a good win, or offer

consolation after a tough defeat. "Y'gotta be good, and y'gotta be lucky," is the oft-spoken philosophy of Missouri's unofficial sports historian.

When Missouri made its 1962 trip to the Bluebonnet bowl in Houston, Stankowski went along to renew acquaintances with old cronies in Texas, among them Harry Viner, "Red" Bourne, Warren Giles and his son Bill. It was an exhilarating trip, capped by Missouri's victory over Georgia Tech.

On his return, Stankowski said gratefully: "I can die now."

The years have treated both Stankowski and Bunker gently. They'll be retiring in excellent health, and each can look forward to many productive years. In addition to his golf and bridge, activities he shares with his wife Gladys, Stan is thinking about researching the material for a book on "Seventy-Five Years of Missouri Football."

The Stankowskis have two children—Jim, 30, an Air Force Major stationed in West Berlin—and Carol, now Mrs. Thomas Mollencamp of Crestwood, Mo. Jim is still single, but Carol is the mother of five youngsters.

Bunker whimsically views his retirement as a chance "to resume a few important activities that were interrupted at about the age of 12 when I became interested in picking up a few two-bitzes."

Specifically, Herb intends to expand his reading—now to include some of the better books rather than trade journals—and with his wife, Margaret, to enjoy more frequent visits with their four married children and three grandchildren. The Bunker clan includes: Herb, Jr., Mary Virginia (Mrs. William Cornelius of Glendale, Mo.), Margaret Jean (Mrs. Philip Huff of Kansas City) and William H.

The coaching-teaching profession doesn't beget instant wealth—or even gradual affluence, but both Stan and Herb have found other compensations along the way. Neither would change a thing.

"Once the virus gets in your blood," says Bunker, "you're not good for much of anything else."

Dr. Paul Ritchie will succeed Bunker as the head of the P.E. department, while Ralph "Boot" Stewart—an all-Big Six center at Missouri in 1946-47—takes over Stan's desk.

B & PA Advisory Council

"In order to present effective academic programs in the years ahead, we in B & P A will need to rely increasingly upon the guidance and assistance of successful experienced business executives." So said Dean Pinkney Walker when he announced the appointment of 15 persons to comprise an Advisory Council for the University's School of Business and Public Administration. Business executives, bankers, accountants, and administrators make up the Council membership; fourteen are M.U. alumni.

Dean Walker said the Advisory Council, which plans at least two meetings a year, is being established to serve as a liaison group for the School with the nation's business community.

"The Council will keep us in closer touch with developments in business and government and will advise us as we restructure and broaden existing programs and formulate new ones," he said.

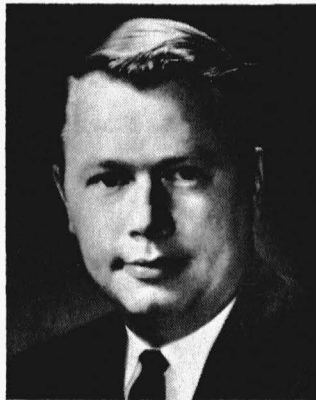

Medicine

Dr. William L. Bradford, native Missourian and noted pediatrician, was honored at the Medical Alumni Luncheon of the Missouri State Medical Association in St. Louis on April 6. He was presented the University of Missouri Alumni Association's Citation of Merit at the meeting, held at the Chase-Park Plaza Hotel in conjunction with the Missouri State Medical Association annual conference. Making the presentation was Dr. Wyeth Hamlin of Hannibal, retiring president of the medical alumni.

As a young physician in 1926, Dr. Bradford went to the University of Rochester School of Medicine where he served on the faculty for 38 years. Last July he relinquished his post as chairman of the Department of Pediatrics and was named Professor Emeritus, but he continues to do some teaching and to see his patients.

He had made distinguished contributions as a physician, teacher, and medical scientist. He became an authority on whooping cough, doing much of the pioneering work on use of the triple vaccine for whooping cough, diphtheria, and tetanus. He is co-discoverer of paraptussis.

Dr. Bradford was born in Sedalia, Missouri in 1898

and after completing high school there in 1916 he entered the University, receiving an A.B. in 1920. He earned his M.D. degree at Washington University of St. Louis in 1923. He interned at St. Louis City Hospital and served two years with the Division of Child Hygiene in Missouri.

In 1926-27, Dr. Bradford was Resident in Pediatrics, Strong Memorial Hospital, University of Rochester School of Medicine and Dentistry. The next year he was a Fellow in Bacteriology and Pathology, University of Rochester School of Medicine. Beginning as Instructor in Pediatrics in 1928, Dr. Bradford advanced to Professor of Pediatrics in 1950 and became chairman of the department two years later, serving in that capacity for 12 years. He was also assistant dean from 1947 to 1954.

He is a former president of the American Pediatric Society and vice-president of the Society for Pediatric Research. Dr. Bradford is a member of the Society for Experimental Biology and Medicine and the Society for American Bacteriologists. Dr. Bradford has authored approximately 100 publications dealing with general pediatrics and infectious diseases, especially whooping cough and paraperitussis.

Their son, Dr. William D. Bradford, is a pediatrician on the staff of Children's Medical Center, Harvard University.

The University of Missouri Alumni Citation of Merit for outstanding achievement in the business world has been presented to Harold S. Hook, president of the National Fidelity Life Insurance Company, Kansas City, Mo.

The formal presentation was made April 9 at the annual Business and Public Administration Week Honors Luncheon, by William C. Tucker, Warrensburg, Mo., president of the University of Missouri Alumni Association.

Mr. Hook received his B.S. in Business Administration degree from the University in 1953, and his A.M. (in accounting) in 1954. He also, during 1953-54, was an instructor in accounting in the School of Business and Public Administration.

Dean Pinkney Walker of the School presided, and Dutton Brookfield, president of Unitog Company, Kansas City, Mo., was master of ceremonies at the luncheon where recognition was given outstanding students and the visiting "Professors for a Day" who lectured before B&PA classes during the week.

Mr. Hook was born in Lee's Summit, Mo., in October, 1931, and was only 31 years old when, in January 1963, he became president of National Fidelity Life Insurance Company. He had first joined that firm in June 1957, as assistant to the president; in 1959 he was elected to the Board of Directors; in 1960 he became administrative vice-president; and in 1961 executive vice-president.

He was in the Naval ROTC at the University, and received the Chicago Tribune Award for the outstanding midshipman and also received the Reserve Officer Association Award. He was commissioned an ensign in June 1954, when he received his A.M. degree and was assigned to the Mine Force of the U. S. Atlantic Fleet, serving three years. During the last two of those years he was executive officer and navigator, and he is currently a lieutenant in the U. S. Naval Reserve.

At the University he was active in campus affairs, serving as president of several student organizations.

Within the life insurance industry Mr. Hook is a chartered life underwriter and has a diploma in agency management from the American College of Life Underwriters. He is a member of the Life Office Management Association; an associate in the Life Office Management Institute; and a member of the American Life Convention and the Life Insurance

Agency Management Association. He is a member also of a number of civic and business organizations.

Mrs. Hook, the former Joanne Hunt, received her B.S. in Education degree from the University here in 1955. Mr. Hook's three brothers are also alumni of the University.

Home Economics

The Citation of Merit was presented on February 18 to Dr. Ercel Sherman Eppright by the University School of Home Economics and the University Alumni Association. Dr. Eppright is assistant dean of the College of Home Economics at Iowa State University where she is also director of the Agricultural and Home Economics Experiment Station. She is known for her research in nutrition, particularly nutrition of school children, and for her work in Iraq as home economics expert with the Food and Agriculture Organization of the United Nations.

Dr. Eppright was born in Isabel, Ill., and attended high school in Odessa, Mo. After receiving her Associate of Arts degree from Howard Payne College, Fayette, Mo., in 1920, she enrolled in the University of Missouri. She has taught in elementary and high schools in Missouri and Kansas. In 1930 she obtained a Master of Science degree from the University of Texas, where she also taught. Her doctorate was obtained from Yale University in 1936.

In 1945, Dr. Eppright joined the Iowa State University staff, and was appointed to her present position in 1961. She previously headed the home economics department at Texas State College for Women at Denton.

Her research includes participation in North Central Regional research programs under the Hatch Act, and with Iowa school children, a project supported in part by General Mills and the National Dairy Council, in cooperation with the USDA and Agricultural Experiment stations of Iowa, Ohio, and Kansas.

Her specific interests have been the effect of the school lunch program on the nutrition of children, food habits of adolescent girls, and nutrition and dental caries in children.

During her year's appointment with the FAO, she was an instructor at the Queen Aliya College for Women in Baghdad. She also was an adviser in developing home economics curriculums of the college and in planning other home economics education.

Her honors include the Borden Award of the American Home Economics Association, the Faculty Citation of Iowa State University Alumni Association, and the Distinguished Alumni Citation, Central College, Fayette, Missouri.

Among her professional and honorary memberships are those in Phi Upsilon Omicron, Pi Lambda Theta, women in education; Omicron Nu, home economics; Sigma Xi, science; Phi Kappa Phi, scholarship; and Delta Kappa Gamma, women teachers. She has been an officer of the American Dietetics Association, American Home Economics Association, and the Texas and Iowa Home Economics Association.

Art for Scholarships

The Irion Art Gallery at 211 Westwood in Columbia serves a dual purpose. In addition to bringing to the University community a greatly appreciated form of art not otherwise readily available, it finances a \$500 scholarship in the School of Education. The scholarship is a memorial to the late Dr. T. W. H. Irion, former Professor of Education and Dean of the School of Education.

When Mrs. Irion started the Art Gallery in 1953 she decided to use the profits to establish a student award as a memorial to Dr. Irion. The income has been used in that manner ever since except that the award has been changed to a scholarship. An addition of \$1,500 in 1964 brought the fund to slightly more than \$15,000. In all probability another \$1,500 will be added in 1965. This will make possible a \$500 scholarship for the 1965-66 school year. Any income over and above this amount will be added to the principal sum until such time as a second \$500 scholarship is possible.

The recipient is chosen during either the junior or senior year to provide a year of study for a senior undergraduate or as a first year graduate student on the campus at Columbia. The selection is made on the basis of scholastic excellence, financial need, and promise of professional success in the field of teaching.

The Art Gallery is unusual in that it is a part of Mrs. Irion's home and brings a wealth of art objects to the area. In fact, she has some things from Europe that can hardly be found elsewhere in this country. One might expect such an enterprise to detract from the atmosphere of the home. It does not. When Mrs. Irion has friends in for tea on Sunday afternoon, as frequently she does, the wealth of art adds to rather than detracts from the occasion. Paintings, prints, figurines, crystal and bric-a-brac of many kinds serve as conversation pieces and are a source of no little pleasure to the guests. And well they may be. They have been garnered from a number of European countries and outstanding sources in the United States.

Mrs. Irion knew her way around in Europe before the Art Gallery was started. She has made an annual expedition ever since. These trips are made in July and August when the demand for her offerings are at low ebb. At that time the house is closed except for the watchful eye and devoted attention of Eliza Scott who has been Mrs. Irion's cook and housekeeper for some 33 years. Tea guests frequently find occasion to visit the kitchen and exchange greetings with Eliza.

The European trips are not all business. Mrs. Irion takes time out for pleasure and sight-seeing. In fact she is doing just that most of the time when she is looking for items to bring back to Columbia. She derives her greatest pleasure and satisfaction in searching out and offering to her friends and patrons paintings with special appeal. In fact it was Albert Genter,

American artist, who encouraged her to open the Gallery. She has sold a number of his water colors.

Many of her paintings are by French artists though more often than not she gets them in Holland or possibly New York. She has several paintings of French scenes by Gisson. Last summer she was attracted to a painting on an iron fence at Green Park in London where beginning artists and those of no great ability are wont to display their wares. After purchasing it she learned that it had been painted by the famous artist Peter Fuller, who had left it there as a lark.

She is especially pleased to have on display a number of Elysa Ash Lord's rice paper etchings. Miss Lord is an American woman who has spent much of her life in the Orient but who now lives in London. Her etchings are becoming quite scarce. Another American, Olis Cook, is represented with paintings of New England scenes.

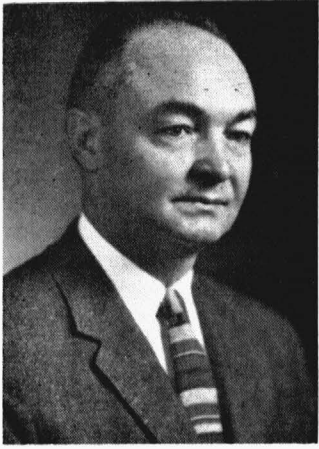
Some of her choice figurines are from Hutschenreuther of Bavaria. She is one of a very few Americans who visit the factories and purchase direct from there. Only one other person in this country handles the exquisite figurines from Dahl-Jensen of Copenhagen. It is here also that she purchases the famous Dahl-Jensen crackle ware.

She also has figurines from two other Copenhagen firms, Royal Copenhagen and Bing & Grøndahl. Along with the porcelain there is both colored glass and crystal from Sweden and Germany.

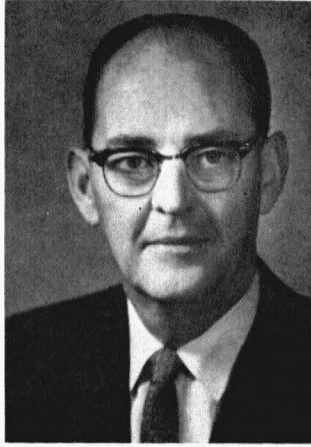
Mrs. Irion also has American porcelains and finds that they compare favorably with those of Europe. Her birds from Boehm of Trenton, New Jersey are so lifelike that one almost expects to hear a warble from a blue bird or to see a flick of the tail by a Carolina wren. Boleslaw Cybis, also of Trenton, from whom she has a variety of figurines, is recognized as a leader in the field of porcelain art.

The Art Gallery is never advertised except by pleased customers. However, persons really interested in art are welcome. The hours are 10:00 to 12:00 in the morning and 2:00 to 5:00 in the afternoon, six days a week. Other hours may be arranged by special appointment. Objects from the Gallery have found their way to many homes throughout Missouri and to other states far and near.

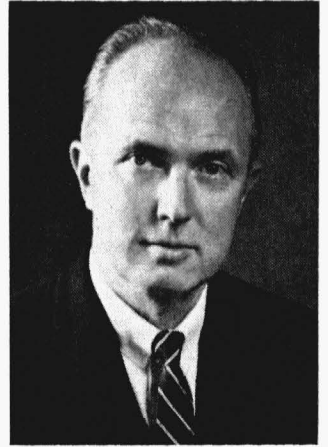
Dr. and Mrs. Irion had planned to establish an art gallery after his retirement. Since that opportunity did not present itself Mrs. Irion found it quite natural to start one with the object of establishing a scholarship in memory of her husband. Dr. Irion was Dean of the School of Education from 1930 to 1945. As Dean and teacher he served the University for nearly a quarter of a century. Before joining the University faculty he had served as acting president of Stephens College. Former students throughout the country remember the inspiration they received in his class room.

Engineering Awards

Three outstanding American engineers, including a University of Missouri alumnus, and a former student, received the Missouri Honor Award for Distinguished Service in Engineering from the University of Missouri at the annual Engineering Convocation March 19 in Jesse Auditorium.

Bronze Missouri medals and citations were presented to: Leo Albert Scott, vice-president of manufacturing for Colgate-Palmolive Company, A.B., B.S. '31; Charles N. Kimball, president of Midwest Research Institute; and Harry F. Barr, General Motors vice-president in charge of engineering staff.

Dr. Joseph C. Hogan, dean of the College of Engineering, presented the awards and citations, and Dr. Kimball delivered the convocation address on "Some Contributions Engineers Can Make to the Economy."

Mr. Barr, General Motors vice-president in charge of the engineering staff, has been with the company since 1929 and was elected to his present position in 1963. He studied mechanical engineering at the University of Missouri and received a bachelor's degree from the University of Detroit. He joined General Motors as a laboratory technician, became Cadillac project engineer in 1937, and has held various posts since that time. He is a member of the Society of Automotive Engineers, the Detroit Engineering Society, American Ordnance Association, Tau Beta Pi.

Dr. Kimball has been president of the Midwest Research Institute in Kansas City since 1950. Before joining the Institute he was technical director of the Research Laboratories Division of the Bendix Corporation, research engineer for RCA, taught in the Graduate School of New York University, and served

as vice-president and director of Aircraft Accessories Corporation. A native of Boston, Mass., he did his undergraduate work in electrical engineering at Northeastern University and received M.S. and Ph.D. degrees from Harvard University. He has received honorary degrees from Northeastern, Park College, and Parsons College. He is a trustee of the Committee for Economic Development, the Hallmark Foundation, the Menninger Foundation, and the University of Missouri at Kansas City, and is on the Board of Regents of Rockhurst College. He is a fellow of the Institute of Electrical and Electronics Engineers, and a member of Tau Beta Pi and the American Association for the Advancement of Science. He is the author of many articles in scientific journals and in business and management publications.

Mr. Scott has served as vice-president of manufacturing for Colgate-Palmolive Company since 1957. He joined the firm in 1931 as an assistant chemist after graduating from the University with A.B. and B.S. in chemical engineering degrees. A native of Missouri, he was born in Lock Springs, Jan. 4, 1909. He has worked at several Colgate plants, in Kansas City; Berkeley, Calif.; Jeffersonville, Ind.; and Jersey City, New Jersey. He became production supervisor in 1940 and three years later was named plant superintendent. In 1950 he was placed in charge of all domestic Colgate-Palmolive plants as general domestic superintendent. He is a member of the American Institute of Chemical Engineers and the University Club of New York. While a student he was captain of the University Polo Team and a member of Tau Beta Pi, national engineering honor society.

around the university

David Lawrence and Edward P. Morgan will be the speakers at the May 7 banquet of the 56th annual Journalism Week at the University. Lawrence is Washington correspondent and founder of the U. S. News and World Report. Morgan is news commentator of the American Broadcasting Company. They will receive the Missouri Honor Award for Distinguished Service in Journalism. Others to be honored include Stewart Hensley, B.J. '34, chief diplomatic correspondent for United Press International, and C. W. Johnson, managing editor of the Springfield (Mo.) News and Leader-Press.

The new Chancellor of the University of Missouri at Kansas City will be Dr. Randall McVay Whaley, now vice-president for Graduate Studies and Research at Wayne State University, Detroit, Michigan. Dr. Whaley will succeed Dr. Carleton F. Scofield, who will retire this summer at 65. The 49-year-old Dr. Whaley is a native of Nebraska, attended Indiana University two years, received two degrees from the University of Colorado and his Ph.D. from Purdue University. He is widely known as a physicist and educational administrator.

A special symposium of topics in space science for selected high school juniors and teachers will be presented on the University's Columbia campus May 13. The symposium is being presented by the University of Missouri Space Sciences Research Center, of which Dr. Ward J. Haas is director, and the National Aeronautics and Space Administration.

Dr. Haas said the invited schools include those in 91 countries of Missouri, 13 in eastern Kansas, 13 in southern Iowa, and 17 in western Illinois. Leading space scientists and engineers will present a series of illustrated lectures. Exhibits, films and guided tours are also scheduled.

Harold W. Condra, Director of Housing, has announced that effective in September the University will modify its program of approving or not approving off-campus housing for students on the Columbia campus. The University will continue to inspect, approve or supervise facilities operated by the University, houses operated by groups recognized as student organizations by the Committee on Student Affairs, and privately-owned residence halls whose owners desire that their facilities be considered a privately-owned segment of the residence halls system. Under the revisions in the Student Housing Rules and Regulations, freshman students less than 21 years of age are expected to reside in the University-supervised housing; all other students shall be permitted to reside in such housing as they and their parents select. Mr.

Condra said the University has been inspecting and approving off-campus housing for "an ever-decreasing percentage of the student body" as a result of the greatly expanded enrollment and changes in housing facilities. He added: "Since the City of Columbia has had since 1958 an ordinance setting forth minimum standards for housing, including accommodations over which the University has no control, and has recently employed a housing inspector who could enforce this ordinance, it seems appropriate at this time that the University should cease acting as an off-campus housing approval agency." Earlier modifications of student housing rules were effected in 1960 when graduate students and undergraduates 23 years of age were permitted to live in other than approved housing, and in 1962 when undergraduates 21 years of age and having a grade point average of 2.75 were given similar permission. It was in 1939 that the University initiated a program of inspecting and approving or disapproving student housing. This was done primarily, Mr. Condra said, because of student complaints concerning the condition of rooming houses and the fact that the city had no ordinances regarding minimum standards for housing.

Newest dormitories to be constructed on the campus will be located on the south side of Rollins Street between Virginia and College avenues. The project calls for the building of two residence halls and dining facilities to accommodate 1,018 unmarried students, with one of the halls to house 509 women students and the other to house 509 men students. A cafeteria building would serve occupants of the two dormitories. Funds for the construction are to come from a \$5,150,000 loan from the Federal Housing and Home Finance Agency. State appropriated funds will not be used in the construction.

Morals for Mankind, a University of Missouri Press publication, now has been published in a Portuguese translation by the Brazilian Institute of Cultural Diffusion, Inc., Sao Paulo. The volume comprises three lectures presented by Herbert W. Schneider in March, 1960, as the inaugural series in the Paul Anthony Brick Lectures at the University. The author is director of the Blaisdell Institute for Advanced Study in World Cultures and World Religions, Claremont, Calif. Publication of the book in Brazil was made possible through the USIA program of assistance to foreign publishers to promote better understanding of the United States and to further Free World goals.

The University's annual Commencement will be held on the evening of Tuesday, June 8. The Summer Session registration is June 14; classes start June 15.

Dr. McGowan is installed

Dr. John F. McGowan, professor of education and assistant director of the Testing and Counseling Service at the University, was installed as president of the American Rehabilitation Counseling Association at its recent meeting in Minneapolis. Rubey revising textbook

Harry Rubey, professor emeritus of civil engineering at the University, is preparing a revised 1966 printing of "The Engineer and Professional Management," a general textbook on the principles and procedures of management for engineers. It is to be published by the Arctcraft Press, Columbia, next January.

Prof. Rubey and Dr. John A. Logan, president of Rose Polytechnic Institute, Terre Haute, Ind., are co-authors of the book, first published in 1963. He is author of numerous publications and of seven engineering textbooks that have gone through many revised editions. A new textbook is also now in production with the Macmillan Publishing Company.

Dr. Van Dyke was born in Sioux City, Ia. He received his A.B. degree from Morningside College, his A.M. degree in 1934 and his Ph.D. degree in 1941 from the University of Missouri. He has served as high school teacher and coach in Lohrville, Ia.; high school teacher, coach, principal and superintendent in Monroe City, Mo.; high school principal in Sedalia; and assistant superintendent of schools of the Missouri State Department of Education. Dr. Van Dyke has taught at the University of Southern California, the University of Colorado, and the University of Missouri as a visiting professor. He was Fulbright Lecturer to the Philippines and North Central Visitor of Dependent Schools of Europe. He has taught at the University of Iowa since 1941.

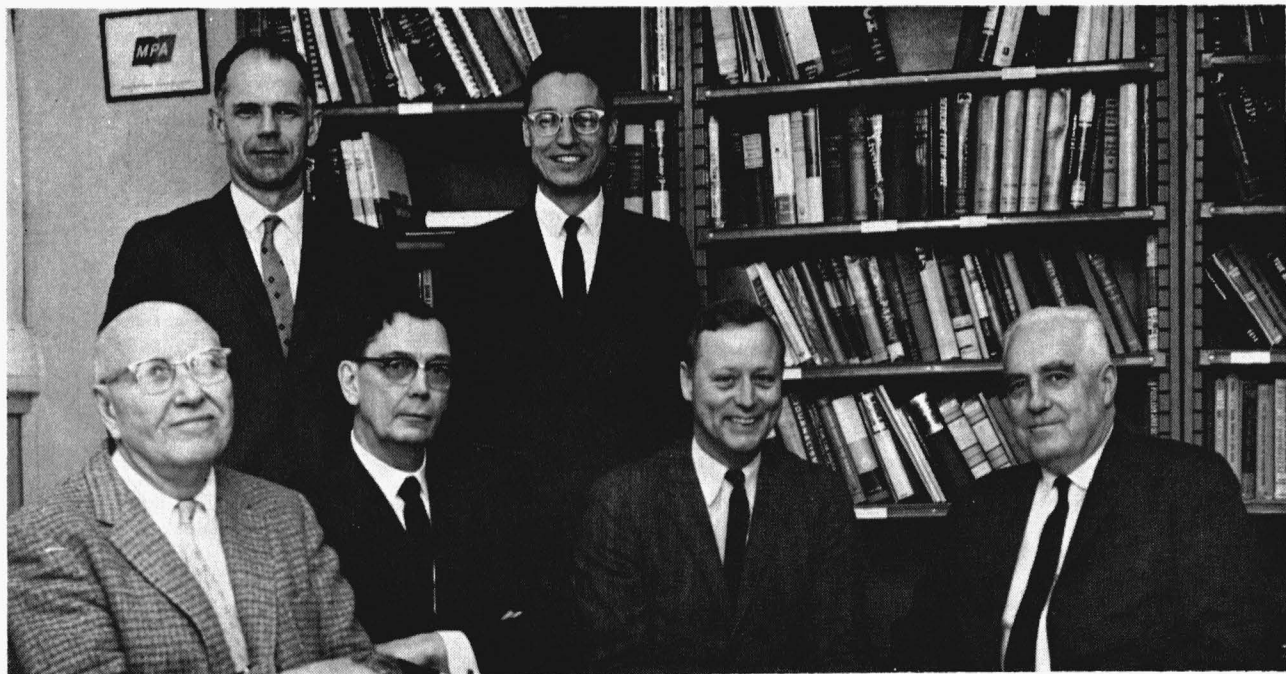
Dr. Glenn Featherston was born in Callao, Mo., and received his A.B. degree in 1929, his A.M. degree

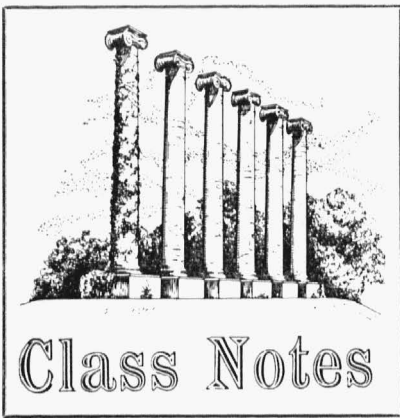
STEWART HALL ADDITION

Stewart Hall, which houses the department of physics, is to have an addition. The Board of Curators has accepted low base bids and approved contracts totaling \$2,121,539 for the construction. Funds will come partly from a state appropriation and partly from a grant from the National Science Foundation.

H. F. Patterson, 1922-1965

Representative H. F. "Pat" Patterson of Columbia, majority floor leader of the Missouri House of Representatives, died unexpectedly of a heart attack in an office of the state Capitol on March 30. He was 42

years old. Mr. Patterson held three degrees from the University: A.B. '49, A.M. and LL.B. '55. He also attended Southwest Missouri State College and the University of Michigan. From 1951 to 1957 he was an assistant professor of business law and political science at the University of Missouri.

From 1955 to 1958 Mr. Patterson served as assistant prosecuting attorney of Boone County, then for a year was Columbia municipal judge.

First elected to the Missouri House in 1960, Mr. Patterson was named in 1963 as one of the two most effective debaters in that legislative session. He was a veteran of World War II, having served for 33 months in the South Pacific. He was a past president of the Missouri Young Democrats, and a past secretary of the Missouri Association for Public Administration. He was a member of the American, Missouri and Boone County Bar associations.

In 1953, Mr. Patterson married the former Miss Margot Truman, who survives along with two sons.

The Patterson family said that a memorial educational fund is being established through the University of Missouri Development Fund, and will be known as the H. F. (Pat) Patterson Memorial. Those wishing to contribute to the Patterson Memorial may send their donations to the University Development Fund, 308 Jesse Hall.

The Kansas City Star, in an editorial, said: "Pat" Patterson of Columbia was a young and energetic leader who had been in the Legislature only since 1961. The fact that he became majority floor leader after two sessions was evidence of his ability. Certainly he represented his district in Boone County well. His interest in the welfare of the University of Missouri went far beyond the facts of his attendance at the school and its location in his county. Representative Patterson was sincerely convinced of the value of higher education to the welfare of the entire state."

Mr. Patterson was lauded by prominent persons throughout the state. He was cited in resolutions adopted by the Missouri House and Senate. Seven Negro members of the House also offered their own resolution, praising his "rare and unique understanding of the problems, needs and aspirations of the Negro constituents of this great state."

Governor and Mrs. Warren E. Hearnes led a delegation of state officials to the memorial services held in Columbia. Nearly 100 members of the General Assembly were convoyed to the services by the Missouri Highway Patrol.
