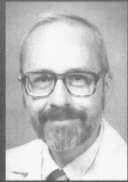

# Association honors faculty and alumni



In recognition of outstanding service and accomplishments, the MU Alumni Association honored recipients of the 23rd annual Faculty-Alumni Awards Sept. 14 in Columbia.

**Eleanor R. Frasier**, BS Ed '61, M Ed '65, received the Distinguished Service Award. Established in 1956, this award recognizes service by an individual whose sustained efforts and support have added to the excellence of the University. Frasier, former president of the Association, initiated the Faculty Development Incentive Grants that fund research projects at MU, and appointed the first members of LINC, the legislative information network committee. A professor emeritus at St. Louis Community College, she is the chairwoman of the building committee for the Donald W. Reynolds Alumni Center.

**Dr. Karl D. Nolph**, the Loren E. Broadus and Curators Distinguished Professor of Medicine, received the Distinguished Faculty Award, which recognizes a faculty member whose sustained efforts in teaching, research and service have added to the excellence of the University. With MU since

1969, Nolph helped pioneer a technique called continuous ambulatory peritoneal dialysis that cleanses the blood of patients with advanced kidney failure, allowing them to lead more normal lives.

The following Faculty-Alumni Award winners were selected for accomplishments in their professional lives and service to the University.

**Dr. Robert E. Bartman**, AB '66, M Ed '71, EdD '75, is Missouri's commissioner of education. He is a member of Gov. John Ashcroft's cabinet and the Commission on Instruction in Washington, D.C.

**William Hubert Bates**, AB '49, is a managing partner and chairman of the law firm of Lathrop, Norquist and Miller in Kansas City. He served on the Board of Curators from 1983 to 1988 and was president in 1987.

**Dr. Carolyn A. Dorsey** is an associate professor of higher education. As coordinator of black studies from 1977 to 1985, she turned it into a strong academic program.

**Dr. Gary A. Dyer**, MD '66, is president of the Missouri State Medical Association and has a private dermatology practice in St. Joseph. He is president of MU's Medical School Foundation.

**Jeanne Vinyard Epple**, BS HE '49, is a former president of the Board of Curators. In 1989, she received the Senior Citation of Merit from the College of Human Environmental Sciences in recognition of extensive volunteer services.

**M. Stanley Ginn**, JD '34, is a former chairman of the board of directors of the Missouri Store Co.

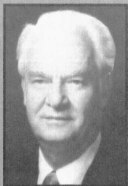

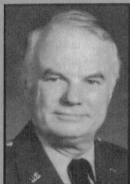

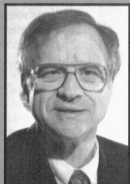

**Sam F. Hamra Jr.**, BS BA '54, JD '59, is chairman of the board and president of Wendy's of Missouri Inc. and a practicing attorney in Springfield, Mo. Chairman of the Jefferson Club trustees, he also serves on MU's Development Council and on the capital fund campaign committee.

**Dr. Winifred Bryan Horner**, MA '60, is the Lillian Radford Chair of Rhetoric and Composition and professor of English at Texas Christian University in Fort Worth and a former MU professor.

**Robert Larry Jinks**, BJ '50, is president and publisher of the *San Jose (Calif.) Mercury News*. Under his editorial leadership, Knight-Ridder's newspapers were awarded 27 Pulitzer Prizes.

**Raymond C. Lewis**, AB '51, JD '54, is a founding partner of Smith, Lewis, Beckett and Powell in Columbia. He is listed in Best Lawyers in America since 1983 as one of the 22 best civil trial attorneys in the state. A former president of the Columbia Board of Education, he founded a charitable corporation that honors outstanding public school educators in Columbia.

**Dr. Peter J. Markie**, department chairman and professor of philosophy, is the author of *Descartes Gambit*, a study of Descartes' theories of self-knowledge and the self.

**Lowell Mohler**, BS Ag '58, executive secretary of the Missouri Farm Bureau, serves as a registered

lobbyist in Jefferson City and Washington, D.C. He coordinates the bureau's legislative and political action programs.

**Dr. Robin Alison Remington** is the Frederick A. Middlebush Chair of political science. An authority on Eastern Europe, she has received two Fulbright Faculty Research Abroad fellowships.

**Col. Charles R. Stribling III**, AB '49, BJ '50, is president of the Missouri Military Academy in Mexico, Mo. He is a former district director of the MU Alumni Association.

**Dr. Charles E. Timberlake**, professor of history, is an expert in Russian history and has been a visiting professor at Moscow State University.

**Dr. Barbara Price Wallach**, associate professor of classical studies, created two popular courses and serves on many committees at MU.

**C. Wallace Walter**, AB '33, JD '35, is the senior member of Mann, Walter, Burkart, Weathers and Walter in Springfield, Mo. He is the former chairman of MU's Development Fund Board and the trustees of the Jefferson Club.

**Dr. Henry W. White**, chairman and professor of physics and astronomy, researches how molecules are absorbed on the surfaces of metals and oxides using optical and electron tunneling spectroscopies.
