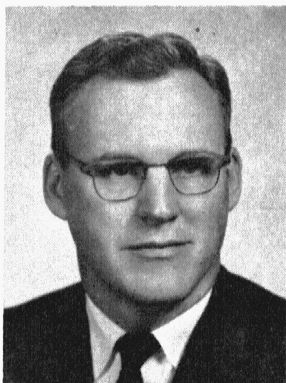


They Receive Alumni Citations of Merit



Dr. HELEN NAHM was awarded the University Alumni Association's first Citation of Merit in Nursing. She is nationally prominent for her contributions to nursing education. Now professor of nursing and Dean of the School of Nursing of the University of California, San Francisco Medical Center, she has held high offices in professional organizations. She holds an Sc.D. degree (1961) from her alma mater, M.U.



OWEN C. DAVIS of New York was cited at the B & P A Week Honors Luncheon. He is a 1937 graduate and is vice-president for management information and control with Sperry Rand Corporation. He formerly was with a subsidiary, Vickers, Inc., for 19 years. He attended Wentworth Military Academy and was on the staff there before entering military service in 1946.



IRVIN FANE, A.B. and LL.B. '28, has practiced law in Kansas City since his graduation. He is senior partner with Spencer, Fane, Britt & Browne. In 1961 he was appointed to Administrative Conference of the United States to study procedures of Federal agencies. Honored at Law Day.



OSCAR V. BATSON, M.D., is a native of Sedalia, Mo. He is professor emeritus of anatomy at the University of Pennsylvania School of Medicine. He was honored at a luncheon meeting of M.U. medical alumni attending the Missouri State Medical Society annual meeting in Kansas City. From Missouri he received his A.B. degree ('16) and A.M. ('18) and an honorary Sc.D. degree ('52).



FREDERICK N. ANDREWS, who received his Ph.D. here in '39, is vice-president for research at Purdue University. One of three recipients of the Citation of Merit at Ag Day Barbecue ceremonies, he was principal speaker on that occasion. He is generally regarded as the first scientist to demonstrate the anabolic activity of stilbestrol in farm animals. He won the Morrison Award in 1961.



Miss **REBA STAGGS** received her Citation at the second annual Home Economics Award Dinner. Afterward she was honored at a reception. Miss Staggs (A.M. '39) is director of Home Economics of the National Livestock and Meat Board. She has served on the Meat Board for more than 25 years and is responsible for much of the research and consumer education work that is done in the field of meats.



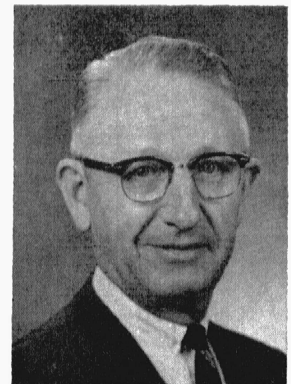
FLINT McROBERTS holds three degrees from M.U.—B.S. in Agr. '39, M.S. '40 and Ph.D. '43. Honored at Ag Day, he operates a highly specialized 700-acre farm near his home town of Monticello, Mo. He is a director of the National Livestock and Meat Board and of the Farm Foundation. He has developed a mechanized feed lot where he finishes more than 1,000 beef cattle annually.



STEPHEN FURBACHER, one of three graduates honored during B & P A Week, is executive vice-president of Amax Aluminum Company, New York, after being president of Kawneer Company, Niles, Mich. He has operations responsibility for all of Amax activities. He is a 1944 graduate.



VICTOR D. BRANNON of St. Louis is director of the Governmental Research Institute. He earned his Ph.D. degree here in 1938. His doctoral dissertation, "State Auditor and Fiscal Control in Missouri Counties," was published as a University of Missouri Study. As a researcher and a teacher of social sciences, he has been a consultant to a number of civic organizations.



J. E. RUTTER, honored at Ag Day, is director of farm and ranch loans for the Prudential Insurance Company of America. After graduating with a B.S. in Agr. in '29, he was a County Agriculture Agent in Missouri for 12 years. Mr. Rutter is a former president of the American Society of Farm Managers and Appraisers.
