YESTERDAY, today, and tomorrow are merged in the history and development of the University of Missouri, established in 1839 in Columbia by an act of the Missouri General Assembly. Founded only 18 years after Missouri was admitted to statehood, the University was modeled along lines set down by Thomas Jefferson, a vigorous advocate of public education, and was the first state university in the Louisiana Purchase Territory. It became a land-grant institution in 1870.

Today the University of Missouri comprises four campuses, of which Columbia is the largest. The second oldest, the University of Missouri - Rolla, was established

in 1870 as the Missouri School of Mines and Metallurgy. In 1963 two new campuses were added—the former private University of Kansas City which became the University of Missouri - Kansas City, and the University of Missouri - St. Louis.

In addition to regular instruction offered in the divisions at all four campuses, the University operates its Extension Division through these campuses. The Extension Division provides formal courses for credit and other educational services throughout the state and a large program of conferences and short courses on the various campuses.
